

ORDINANCE NO. 629

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, ESTABLISHING A PRICE SCHEDULE FOR LOTS IN THE KIRKLAND CEMETERY, ESTABLISHING THE PRICE AT \$75.00 FOR LOTS IN THE PREVIOUSLY UNPLATTED PORTION OF KIRKLAND CEMETERY KNOWN AS BLOCKS 20 and 21 LAWN HAVEN AND ESTABLISHING PRICES FROM \$35.00 TO \$75.00, FOR LOTS IN THE NEW PORTION OF THE KIRKLAND CEMETERY KNOWN AS BLOCK 22, EVERETT MEMORIAL.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:
