

ORDINANCE NO. 636

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON SETTING WAGE AND SALARY SCHEDULES FOR THE POLICE, STREET, WATER, SEWER, PARK AND CEMETERY DEPARTMENTS, CITY HALL SUPERINTENDENT AND CEMETERY CARETAKER, RAISING SOME SALARIES AND PAY SCHEDULES AND AMENDING ANY ORDINANCE INCONSISTENT THEREWITH TO TAKE EFFECT AS OF JANUARY 1, 1953.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. The salaries of the departmental superintendents shall be as follows:

Water Superintendent	\$350.00	per month
Street Superintendent	350.00	per month
Sewer Superintendent	350.00	per month
Police Chief	350.00	per month
City Hall Superintendent	350.00	per month
Park Superintendent	350.00	per month

Section 2. The salaries of the Water Department Leadmen of which there shall be two (2) shall be \$315.00 each per month.

Section 3. The salary of the Water Shed and Reservoir Supervisor shall be \$350.00 per month with \$25.00 per month extra during the four (4) summer months.

Section 4. The salaries of the Police Department shall be as follows:

Two Sergeants	\$315.00	per month
Police Patrolmen	305.00	per month
Desk Clerk	200.00	per month

Section 5. The salary of the Cemetery Caretaker shall be \$175.00 per month.

Section 6. All regular city employees for the departments of Water, Sewer, Street, City Hall and Parks shall receive \$290.00 per month.

The Street Department Heavy Equipment Operator shall receive \$315.00 per month.

Section 7. The salary of the City Engineer shall be \$4500.00 per year, payable semi-monthly.

Section 8. That all Ordinances or parts of Ordinances inconsistent herewith be and the same hereby are repealed to the extent necessary to make this Ordinance effective.

Section 9. The salaries herein provided shall take effect as of January 1, 1953.

Section 10. This Ordinance shall be in force five days from and after its passage by the Council, approval by the Mayor, and publication according to law.
