ORDINANCE NO. 644

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON PROVIDING FOR THE LICENSING OF SIDE SEWER CONTRACTORS REQUIRING PERMITS FOR INSTALLATION OF SIDE SEWERS ESTABLISHING FEES THEREFOR AND PROVIDING FOR FINAL INSPECTION BY CITY.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That in addition to existing Ordinances and requirements of the City of Kirkland it shall hereafter be required that all individuals, persons, corporations or other entity or group installing or repairing side sewers in the City of Kirkland shall be licensed by the City of Kirkland and shall qualify according to the requirements of this Ordinance.

Section 2. Any such person, corporation or group operating as a side sewer contractor shall secure a license from the City Clerk which shall be valid for a period of one (1) year from date of issue. Contractors shall pay the sum of \$25.00 for his original license and for each years renewal thereafter, he shall pay the City \$15.00.

Section 3. Each and every side sewer contractor in the City of Kirkland licensed by the City shall at all times have and maintain a performance bond in the sum of not less than \$1,000.00, which shall guarantee faithful performance of such licensee's obligations.

Section 4. All applicants for side sewer contractor's license shall be examined by the City Engineer and by the City Sewer Superintendent and the granting of license shall be contingent upon approval by said City officials after examination.

Section 5. Any and all side sewer contractors or individuals doing their own side sewer work shall be required to have insurance holding the City harmless in case of accident or damage, and must furnish evidence of such insurance at the time permit is issued.

Section 6. Before any contractor or individual shall perform any side sewer work in the City of Kirkland, a permit shall be secured from the office of the City Clerk. This permit shall be valid for a period of 30 days from date of issue. The sum of \$10.00 shall be paid by each applicant for side sewer permit. A copy of the permit shall also be furnished to the Street Superintendent and the Sewer Superintendent of the City of Kirkland.

Section 7. All side sewer work shall be done according to the requirements and specifications of Ordinance No. 631 of the City of Kirkland. All side sewers shall be subject to final examination by the City Engineer before work is covered.

Section 8. It is further required that at the time that permit for side sewer installation is issued, the individual or side sewer contractor must pay the cost of pavement restoration as required by the City of Kirkland.

Section 8. Requirements of this Ordinance shall apply equally to individuals doing their own work or individual corporations or businesses operating as side sewer contractors.

Section 9. This Ordinance shall be in force five days from and after its passage by the Council, approval by the Mayor, and publication according to law.
