ORDINANCE NO. 648

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, REPEALING A PORTION OF ORDINANCE NO. 612 RELATING TO WATER RATES OUTSIDE THE CITY OF KIRKLAND LIMITS AND RE-ENACTING THE SECTION TO PROVIDE THAT OUTSIDE THE CORPORATE BOUNDARY LINES OF THE CITY THE CHARGE FOR THE FIRST ONE THOUSAND (1000) CUBIC FEET OR LESS SHALL BE \$3.50, THAT AFTER THE MINIMUM ONE THOUSAND (1000) CUBIC FEET OF WATER USED THE NEXT TEN THOUSAND (10,000) CUBIC FEET SHALL COST TEN CENTS (.10) PER ONE HUNDRED (100) CUBIC FEET, AND OVER ELEVEN THOUSAND (11,000) CUBIC FEET FIVE CENTS (.05) PER ONE HUNDRED (100) CUBIC FEET, THESE PRICES PERTAINING TO ONE-HALF (1/2) AND THREE-QUARTER (3/4) METERS ONLY.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That / Section 2 of Ordinance No. 612 of the City of Kirkland which reads as follows:

"Outside of the corporate boundary lines of the City of Kirkland the following rates will prevail:

First 1000 cubic feet or less	- - - - -	\$ 3.50
Next 10,000 cubic feet per 100 cubic feet	- - - - -	.15
Over 11,000 cubic feet per 100 cubic feet	- - - - -	.07½

These prices pertain to 1/2 and 3/4 meters only."

hereby is repealed and re-enacted to read as follows:

"Outside of the corporate boundary lines of the City of Kirkland the following rates will prevail:

First 1000 cubic feet or less	- - - - -	\$ 3.50
Next 10,000 cubic feet per 100 cubic feet	- - - - -	.10
Over 11,000 cubic feet per 100 cubic feet	- - - - -	.05

These prices pertain to 1/2 and 3/4 meters only."

Section 2. The schedule of charges herein enacted shall be and become effective with the month of June, 1953.

Section 3. Any part of Ordinances herein repealed which are re-enacted in form or substance in this Ordinance shall not be construed as new enactments but as continuances and amendments of such Ordinances or parts of Ordinances, and all other provisions as to charges, rates

and other provisions regarding the water service of the City of Kirkland shall be and remain unchanged.

Section 4. This Ordinance shall be in force and take effect five days from and after its passage by the Council, its approval by the Mayor and its publication according to law.
