ORDINANCE NO. 650

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, ESTABLISHING RATES FOR GARBAGE COLLECTION, PROVIDING THAT THERE SHALL BE NO EXEMPTIONS FOR ANY BUSINESS FROM COMPULSORY GARBAGE COLLECTION, ESTABLISHING TWO BUSINESS CLASSES FOR RATE PURPOSES, DETERMINING PICK-UP AREA FOR ALL CLASSES, AND PROVIDING THAT CANS AND GARBAGE SHALL BE READY FOR PICK-UP IN BUSINESS AREA BY 7:30 A.M., ALL IN ACCORDANCE WITH AND PURSUANT TO ORDINANCE NO. 637 OF THE CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO OPDAIN AS FOLLOWS:

Section 1. That the provisions of Ordinance No. 637 allowing exemptions from compulsory garbage collection by the filing of a Claim of Exemption in certain instances shall not apply to business establishments or firms and there shall be no exemption from garbage collection for any business, commercial or industrial firm or establishment.

Section 2. That for business establishments in the City of Kirkland there shall be two types as follows:

Type 1 shall consist of all retail and industrial type operations and in addition all doctors and dentists offices.

Type 2 shall consist of all professional offices and personal services type of establishments, including real estate offices, insurance offices, lawyers, barber shops, photo shops, engineers, loan offices, credit offices, accountants and public relation firms.

Type 1 shall have six collections per week and Type 2 shall have three collections per week with rates in accordance with the schedules hereinafter provided and established.

Section 3. All property owners and/or business firms or locations shall on the day of pick-up have their garbage cans or containers within twenty five (25) feet from the property line on the street or alley, whichever is used by the garbage pick-up truck.

Section 4. In the business area and in relation to any owner or user under business classification, the garbage cans shall be available for pick-up by 7:30 a.m. on the days established for pick-up service.

Section 5. The rates to be charged for the garbage collection service in the City of Kirkland shall be as follows:

- Business Type 1 - \$4.50 per month six collections per week
- Business Type 2 - \$2.50 per month three collections per week
- Residential - \$1.00 per month one collection per week
- Apartment House - \$2.00 per month two collections per week
- Hotels - pick-ups shall be daily and charged as business establishments

Motels, auto courts and trailer camps will be picked up weekly and residential rate charged for each unit. Property owner or landlord shall be charged for total services rendered.

In all classes and areas under all charges extra cans shall be picked up at the rate of .10¢ per can per pick-up.

Where it is permissible to collect rubbish for pick-up in other than garbage cans it shall be charged for as if it has been placed in such cans of regular size. And where requested collection is of such an unusual size or at sometime other than regular collections are made at the premises, a special charge based on the amount involved shall be made and the extra expenditure of labor and equipment charge shall be set by the garbage collector under limitations as established by the proper Department of the State of Washington.

Section 6. This Ordinance shall be in force five (5) days from and after its passage by the Council, approval by the Mayor and publication according to law.
