

ORDINANCE NO. 654

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.080, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1953, AND APPROPRIATING THE SUM OF TWO THOUSAND TWO HUNDRED DOLLARS (\$2200.00) AND AUTHORIZING THE IMMEDIATE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF HEATING, LIGHTING, AND MAINTAINING THE CITY HALL AND PAINTING THE CITY HALL AND CANNERY BUILDING OWNED BY THE SAID CITY OF KIRKLAND IN EXCESS OF THE ESTIMATED COST OF THE EXPENSE OF THE GENERAL GOVERNMENT WHICH INCLUDES THE MAINTENANCE AND OPERATION OF THE SAID CITY HALL AND CANNERY BUILDING.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the health and welfare of the population of the City of Kirkland in that the City Hall and Cannery Building of the City cannot be properly maintained and protected without immediate expenditures for painting, heating, lighting and maintenance, and it is necessary that such work be done to adequately serve the needs of the citizens of Kirkland, and additional funds in the amount of Two Thousand Two Hundred Dollars (\$2,200.00) are necessary to pay the expenses thereof for the balance of the fiscal year of 1953;

AND WHEREAS, the necessity of said expenditures could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year of 1953, and the appropriation therefor by the City Council, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of the sum of Two Thousand Two Hundred Dollars (\$2,200.00) to be used for said uses and purposes, and there is hereby appropriated for the General Government of the City of Kirkland for the specified uses of painting the City Hall and Cannery Building, and heating, lighting, and maintaining said City Hall, the sum of Two Thousand Two Hundred Dollars (\$2200.00). It is further

ordained that the sum of Two Thousand Two Hundred Dollars (\$2200.00) be transferred from the Replacement Fund of the Water Department as a loan from said Replacement Fund to be repaid to that Fund without interest during the fiscal year of 1954.

This Ordinance is necessary for the immediate preservation of the public health and welfare of the residents and citizens of the City of Kirkland, and is hereby declared to be in full force and effect immediately.

Introduced the 3rd day of August, 1953, an emergency declared and this Ordinance passed and approved this 17th day of August, 1953.
