ORDINANCE NO. 655

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33080, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1953, AND APPROPRIATING THE SUM OF EIGHT THOUSAND DOLLARS (\$8000.00) AND AUTHORIZING THE IMMEDIATE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF PAYING ENGINEERING FOR STREET BOND ISSUE, ERECTING AN EMERGENCY BULKHEAD AT THIRD AVENUE AND SECOND STREET, PAYING FOR BULLDOZING ON WATER FRONT AND FOR UPKEEP AND MAINTENANCE OF STREET EQUIPMENT IN EXCESS OF THE ESTIMATED COST OF THE EXPENSE OF THE GENERAL GOVERNMENT WHICH INCLUDES SUCH EXPENSES.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the health and welfare of the population of the City of Kirkland in that expenditures became necessary and are necessary for engineering services, emergency bulkhead at Third Avenue and Second Street, water front bulldozing, upkeep and maintenance of equipment in the Street Department without which the City could not be properly maintained and protected, and it is necessary that such work be done to adequately serve the needs of the citizens of Kirkland, and additional funds in the amount of Eight Thousand Dollars (\$8000.00) are necessary to pay the expenses thereof for the balance of the fiscal year of 1953;


AND WHEREAS, the necessity of said expenditures could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year of 1953, and the appropriation therefor by the City Council, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of the sum of Eight Thousand Dollars (\$8000.00) for the specified uses of paying for engineering in connection with the proposed street improvement bond issue, construction of emergency bulkhead at Third Avenue and Second Street paying for bulldozing on water front and for maintenance and upkeep of the equipment in the Street Department, the sum of Eight Thousand Dollars (\$8000.00). It is further ordained that the sum of Eight

Thousand Dollars (\$8000.00) be transferred from the Replacement Fund of the Water Department as a loan from said Replacement Fund to be repaid to that Fund without interest during the fiscal year of 1954.


This Ordinance is necessary for the immediate preservation of the public health and welfare of the residents and citizens of the City of Kirkland, and is hereby declared to be in full force and effect immediately.

Introduced the ~~17th~~ day of August, 1953, an emergency declared, and this Ordinance passed and approved this ~~17th~~ day of ^{September} ~~August~~, 1953.




