

ORDINANCE NO. 658

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING TWO PUBLIC PARKING AREAS IN THE CITY OF KIRKLAND TO BE PUBLIC WAYS AND AREAS FOR THE PURPOSE OF REGULATING PARKING AND DRIVING THEREON, AUTHORIZING THE POSTING OF PARKING LIMITS AND MAKING VIOLATIONS OF PARKING OR DRIVING LAWS VIOLATIONS OF THE MOTOR VEHICLE CODE OF THE CITY OF KIRKLAND TO BE PUNISHED IN LIKE MANNER OR DEGREE AS SIMILAR VIOLATIONS ON STREETS OR WAYS.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. The parking lot area at the southwesterly corner of Central Avenue and Main Street in the City of Kirkland, and the parking lot area of the City of Kirkland on the shore of Lake Washington between Kirkland Avenue and Central Way, shall be and are public ways and areas for the use and operation including parking of motor vehicles in the same manner and degree as all other streets, alleys, areas and ways for the purpose of enforcing the Motor Vehicle Code of the City of Kirkland.

Section 2. The Mayor or Chief of Police is hereby authorized to post the public parking areas above described for parking restrictions as to place and limit of time and also as to speed limits on said parking lot areas. It is specifically provided that there shall be a two hour parking time limit in the entire lot on the southwesterly corner of Central Way and Main Street, and a similar two hour time parking limit on the most easterly portion of the water front lot which is now lined for parking and posted. Parking to the west of the roadway entering the water front lot from Kirkland Avenue shall be all day parking but subject to restriction against overnight parking.

Section 3. Violations of the provisions of this Ordinance as to parking time limit or violations of any driving regulation occurring on said parking lot areas shall be punishable in like manner

and degree as to amount of fine or length of imprisonment as similar offenses on other public ways or areas.

Section 4. This Ordinance shall be in force and take effect five days from and after its passage by the Council, its approval by the Mayor and publication according to law.
