

ORDINANCE NO. 661

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.080, WHICH EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1954, AND APPROPRIATING THE SUM OF \$6000.00 AND AUTHORIZING THE IMMEDIATE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF MAKING A SETTLEMENT PAYMENT TO THE UNITED STATES GOVERNMENT FOR ADVANCE PLANNING LOAN WASH. 45-P-2 STREET IMPROVEMENTS, KIRKLAND, WASHINGTON, AND THAT THIS SUM BE SECURED BY BORROWING FROM THE WATER-SEWER REPLACEMENT RESERVE FUND TO BE PAID WITHOUT INTEREST UNDER THE 1955 BUDGET.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the health and welfare of the population of the City of Kirkland, in that the United States Government has made claim for repayment of a \$20,000.00 advance planning loan known as Wash. 45-P-2 Street Improvements, Kirkland, Washington, for funds advanced to the City of Kirkland in 1945 and now through negotiations it is possible to settle said claim for the sum of \$6000.00, which sum must be paid immediately and which settlement is in the best interests of the financial welfare of the City of Kirkland.

AND WHEREAS, the necessity of said expenditure could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year of 1954, and the appropriations therefor, by the City Council now therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of \$6000.00 for the specified use and purpose of paying to the Treasurer of the United States in full settlement of the claim of the United States Government for advanced planning loan in the amount of \$20,000.00 being Wash-45-P-2 Street Improvements, Kirkland, Washington.

IT IS FURTHER ORDAINED that the sum of \$6000.00 be transferred from the Water-Sewer Replacement Reserve Fund as a loan from said replacement reserve fund, to be budgeted and repaid to that fund without interest

during the fiscal year of 1955.

This Ordinance is necessary for the immediate preservation of the public health and welfare of the residents and citizens of the City of Kirkland and it is hereby declared to be in full force and effect immediately.

Introduced the 3rd day of May, 1954, an emergency declared and this Ordinance passed and approved this 17<sup>th</sup> day of May, 1954.
