

ORDINANCE NO. 674

AN ORDINANCE of the City of Kirkland, Washington, specifying and adopting a plan for the acquisition, construction and installation of certain additions and improvements to and extensions of the combined water and sewerage system of the city, declaring the estimated cost thereof, authorizing the issuance of water and sewer revenue bonds of the city in the principal sum of \$100,000 to provide the money to pay such cost, and declaring an emergency.

WHEREAS, the City of Kirkland now owns, operates and maintains systems of water supply and distribution and of sanitary sewage disposal which systems were combined as authorized by law by Ordinance No. 576 of the city, passed and approved July 18, 1949; and

WHEREAS, each of said systems is in need of certain additions, improvements and extensions in order to furnish the city, its inhabitants and people living in the vicinity thereof with an adequate supply of water and with proper sewage collection, disposal and treatment facilities; and

WHEREAS, in order to provide the funds necessary to acquire, construct and install said additions, improvements and extensions, it is deemed necessary that the city issue and sell its water and sewer revenue bonds in the total principal sum of \$100,000;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kirkland, Washington as follows:

Section 1. The following described plan for the acquisition, construction and installation of additions and improvements to and extensions of the water supply and distribution system and sanitary sewage disposal system of the city, which systems have been combined as provided by law, is hereby proposed, specified and adopted, to wit:

WHEREAS, in order to provide the funds necessary to acquire, construct and install said additions, improvements and extensions, it is deemed necessary that the city issue and sell its water and sewer revenue bonds in the total principal sum of \$100,000;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kirkland, Washington as follows:

Section 1. The following described plan for the acquisition, construction and installation of additions and improvements to and extensions of the water supply and distribution system and sanitary sewage disposal system of the city, which systems have been combined as provided by law, is hereby proposed, specified and adopted, to wit:

A. The city shall install water mains of the approximate size and length hereinafter specified in, on, along and under the following named streets and avenues:

2400 feet of 4" and 170 feet of 6" transite water main on Market Street from Central Way to 10th Avenue

600 feet of 6" transite water main to replace existing wood main on Commercial Avenue from Lake Street to 3rd Street

250 feet of 6" transite water main to replace existing wood main on Main Street from Commercial Avenue to Kirkland Avenue

800 feet of 6" transite water main to complete permanent installation of water system on Kirkland Avenue and State Street So. from Lake Street to 3rd Street So.

8" transite pipe to connect existing mains on 116th Avenue to existing mains on Central Way and 7th Avenue by installation of 2100 feet of such pipe on 7th Avenue from Central Way to 116th Avenue N.E.

6" transite water main to connect existing mains to Market Street and 1st Street by installation of 300 feet of such pipe on 18th Avenue from Market Street to 1st Street

80 feet of 4" transite water main at Lake Avenue and Kirkland Avenue

B. The city shall construct sanitary sewer mains of approximately 1250 feet of 8" concrete pipe, 1350 feet of 10" concrete pipe, and 100 feet of 12" cement asbestos pipe on each side of Lake Avenue South from 2nd Avenue South to the south city limits.

The city shall extend the existing outfall line approximately 200 feet into Lake Washington with 48" pipe.

The city shall acquire a future sewer treatment plant site

for the south area of Kirkland in the general vicinity of Lake Washington Boulevard and N.E. 40th Street, and another future sewer treatment plant site for the north area of Kirkland in the vicinity of Market Street and 104th N.E.

C. The city shall clear and grade and install tiling and drainage facilities on the site acquired for its Water-Sewer Department centralized warehouse, storage and city shop, shall construct access roads, fencing and storage sheds, and shall provide for the necessary engineering and architectural services preparatory to construction of the final buildings to be located thereon.

The above described water and sewer mains and lines shall be installed with all necessary appurtenances and shall be connected with the existing water supply and distribution and sewage disposal systems of the city wherever found to be necessary.

The city shall acquire all property, both real and personal, easements, franchises and rights-of-way necessary to carry out the above plan of improvements.

Such plan shall be subject to such additions or changes as to details or other changes not affecting the main general parts of such plan as hereinbefore set forth as shall be authorized by the City Council either prior to or during the actual course of construction.

Section 2. The estimated cost of the acquisition, construction and installation of the above described plan of additions and improvements to and extensions of the combined water and sewerage system of the city is hereby declared to be, as near as may be, the sum of \$100,000, which cost shall be paid from the proceeds of the sale of the water and sewer revenue bonds of the city hereinafter authorized.

Section 3. The city does hereby propose and adopt as an integral part of the plan for the acquisition, construction and installation of said additions and improvements to and extensions of its combined water and sewerage system that it shall issue and sell its water and sewer revenue bonds in the principal sum of \$100,000.

The exact date, form, terms, maturities and covenants of said bonds shall be as hereafter fixed by ordinance.

Section 4. This ordinance is declared to be one necessary for the immediate preservation of the public peace, property, health and safety of the people of the City of Kirkland, Washington. An emergency is hereby declared to exist, and this ordinance is hereby declared to be in full force and effect from and after its passage, approval and publication as provided by law.

PASSED by the Council of the City of Kirkland, Washington and approved by its Mayor at a regular meeting of said Council held this 6th day of June, 1955.
