

ORDINANCE NO. 681

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING SALARIES AND WAGES OF CERTAIN CITY EMPLOYEES IN ACCORDANCE WITH THE BUDGET ADOPTED FOR 1956.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

The salary and wages of designated City Employees of the City of Kirkland shall be in accordance with the budget adopted for 1956 as follows:

Section 8. The foregoing salaries are all yearly amounts to be paid on a twelve month's basis. All city salaries and/or wages previously set by ordinance and not hereby changed, shall be and remain the same as previously established.

Section 9. The salaries and wages as fixed by this ordinance shall be the established salaries from January 1, 1956 until changed by the City Council.

Section 10. This ordinance shall be in force and effect from and after its passage, approval and publication according to law.
