AN ORDINANCE ANNEXING CERTAIN TERRITORY ADJACENT TO THE CITY OF KIRKLAND AND LYING EASTERLY THEREOF:

WHEREAS, A Petition has been filed with the City Council of the City of Kirkland for the annexation to the City of Kirkland of certain property hereinafter legally described, and

WHEREAS, The Petition was presented to the City Council of Kirkland in regular session on April 2, 1956, at which time it was found that the Petition contained more than 75% in value according to the assessed valuation for general taxation of the property for which annexation is petitioned of signers, and contained a legal description of said property, and

WHEREAS, Pursuant to notice posted and published according to law, a public hearing was had on said Petition at 8:00 P.M. o'clock, Monday, May 7, 1956, in the Council Chambers, Kirkland City Hall, Kirkland, Washington, to consider said annexation, and at such hearing it appearing suitable and proper that annexation be granted and no protestants appearing, now therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That that certain territory situate in King County,

Washington, lying adjacent to the present boundaries of the City of

Kirkland and situated Easterly thereof described as follows, to-wit:

Lots 17 to 24, inclusive, Block 232 and Lots 11 to 32, inclusive, Block 233, ALL in Supplementary Plat of Kirkland as per plat recorded in Volume 8 of Plats, page 5, records of King County, Washington, AND ALSO Lots 8 to 16, inclusive, and 25 to 32, inclusive, of Block 232, Supplementary Plat of Kirkland recorded King County, Washington; TOGETHER WITH intervening, included and adjacent streets, roads and alleys, King County, Washington;

be and the same hereby is annexed to the City of Kirkland and made a part thereof.

Section 2. This Ordinance shall be in force and take effect five (5) days from and after its passage by the Council, approval by the

Mayor and publication according to law.
