

ORDINANCE NO. 703

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING SALARIES AND WAGES OF CERTAIN CITY EMPLOYEES IN ACCORDANCE WITH THE BUDGET ADOPTED FOR 1957.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

The salary and wages of designated City Employees of the City of Kirkland shall be in accordance with the budget adopted for 1957 as follows:

Section 10. The salaries and wages as fixed by this ordinance shall be the established salaries from January 1, 1957 until changed by the City Council.

Section 11. This ordinance shall be in force and effect from and after its passage, approval and publication according to law.


