

ORDINANCE NO. 711

AN ORDINANCE ANNEXING CERTAIN TERRITORY ADJACENT TO THE CITY OF KIRKLAND, WASHINGTON, LYING EASTERLY THEREOF AND DESCRIBED AS FOLLOWS:

Beginning at the intersection of the west margin of 108th Avenue Northeast or 6th Street South in the City of Kirkland with the southerly margin of secondary state highway No. 2-d; thence westerly along said southerly margin to the present Kirkland city limits; thence northerly and northeasterly, following the present line of said Kirkland city limits to intersect the westerly margin of 108th Avenue Northeast or 6th Street South; thence southerly along the westerly margin of 108th Avenue Northeast or 6th Street south to the point of beginning, all in King County, Washington.

WHEREAS, a Petition has been filed with the City Council of the City of Kirkland for the annexation to the City of Kirkland of certain property hereinafter described, and

WHEREAS, the Petition was presented to the City Council of Kirkland in regular session on February 18, 1957, at which time it was found that the Petition contained more than 75% in value according to the assessed valuation for general taxation of the property for which annexation is petitioned of signers, and contained a legal description of said property together with a plat or map outlining the boundaries of said property, and

WHEREAS, pursuant to notice posted and published according to law, a public hearing was had on said Petition at 8:30 P.M. o'clock, Monday 18, 1957 in the Council Chambers, Kirkland City Hall, Kirkland, Washington to consider said annexation, and at such hearing it appearing suitable and proper that annexation be granted and no protestants appearing, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That that certain territory situate in King County, Washington, lying adjacent to the present boundaries of the City of Kirkland and situated Easterly thereof described as follows, to-wit:

Beginning at the intersection of the west margin of 108th Avenue Northeast or 6th Street South in the City of Kirkland with the southerly margin of secondary state highway No. 2-D; thence westerly along said southerly margin to the present Kirkland city limits; thence northerly and northeasterly, following the present line of said Kirkland city


limits to intersect the westerly margin of 108th Avenue Northeast or 6th Street South; thence southerly along the westerly margin of 108th Avenue Northeast or 6th Street south to the point of beginning, all in King County, Washington,

be and the same hereby is annexed to the City of Kirkland and made a part thereof.


Section 2. This Ordinance shall be in force and take effect five (5) days from and after its passage by the Council, approval by the Mayor and publication according to law.
