

ORDINANCE NO. 722

AN ORDINANCE ANNEXING CERTAIN TERRITORY ADJACENT TO THE CITY OF KIRKLAND, WASHINGTON, LYING EASTERLY THEREOF AND DESCRIBED AS FOLLOWS:

Beginning at the intersection of the North boundary of Northeast 86th Street (or 6th Avenue in the City of Kirkland) with the present City Limits of Kirkland, King County, Washington; thence Easterly along the said North boundary of Northeast 86th Street (or 6th Avenue in the City of Kirkland) to the Southeast corner of Lot 23, Block 224, Supplementary Plat to Kirkland; thence Northerly in a line coincident with the East boundary of lots 17 to 23 inclusive, Block 224, Supplementary Plat to Kirkland and extended Northerly to the Southeast corner of Lot 23, Block 227, Supplementary Plat to Kirkland; thence Easterly along the North boundary of Northeast 87th Street (or 7th Avenue in the City of Kirkland) to the Southeast corner of Lot 25, Block 227, Supplementary Plat to Kirkland; thence Northerly along the East line of Lots 25 and 15, said Block 227 to the Northeast corner of said Lot 15 and the Kirkland City Limits; thence following the Kirkland City Limits Westerly and Southwesterly to the point of beginning.

WHEREAS, a Petition has been filed with the City Council of the City of Kirkland for the annexation to the City of Kirkland of certain property hereinafter described, and

WHEREAS, the Petition was presented to the City Council of Kirkland on June 17, 1957, at which time it was found that the Petition contained more than 75% in value according to the assessed valuation for general taxation of the property for which annexation is petitioned of signers, and contained a legal description of said property together with a plat or map outlining the boundaries of said property, and

WHEREAS, pursuant to notice posted and published according to law, a public hearing was had on said Petition at 8:00 P.M. o'clock on July 15, 1957 in the Council Chambers, Kirkland City Hall, Kirkland, Washington to consider said annexation, and at such hearing it appearing suitable and proper that annexation be granted and no protestants appearing, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That that certain territory situate in King County, Washington, lying adjacent to the present boundaries of the City of Kirkland and situated Easterly thereof described as follows, to-wit:

Beginning at the intersection of the North boundary of Northeast 86th Street (or 6th Avenue in the City of Kirkland) with the present City Limits of Kirkland King County, Washington; thence Easterly along the said North boundary of Northeast 86th Street (or 6th Avenue in the City of Kirkland) to the Southeast corner of Lot 23, Block 224, Supplementary Plat to Kirkland; thence Northerly in a line coincident with the East boundary of Lots 17 to 23 inclusive, Block 224, Supplementary Plat to Kirkland and extended Northerly to the Southeast corner of Lot 23, Block 227, Supplementary Plat to Kirkland; thence Easterly along the North boundary of Northeast 87th Street (or 7th Avenue in the City of Kirkland) to the Southeast corner of Lot 25, Block 227, Supplementary Plat to Kirkland; thence Northerly along the East line of Lots 25 and 15, said Block 227 to the Northeast corner of said Lot 15 and the Kirkland City Limits; thence following the Kirkland City Limits Westerly and Southwesterly to the point of beginning,

be and the same hereby is annexed to the City of Kirkland and made a part thereof.

Section 2. This Ordinance shall be in force and take effect five (5) days from and after its passage by the Council, approval by the Mayor and publication according to law.
