

ORDINANCE NO. 733

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING SALARIES AND WAGES OF CERTAIN CITY EMPLOYEES IN ACCORDANCE WITH THE BUDGET ADOPTED FOR 1958.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:


Section 9. The foregoing salaries are all yearly amounts to be paid on a twelve months basis, except for sums designated for Life Guards, Part Time and Extra Help.

Section 10. The salaries and wages as fixed by this ordinance shall be the established salaries from January 1, 1958 until changed by the City Council.


Section 11. This ordinance shall be in force and effect from and after its passage, approval and publication according to law.
