ORD INANCE NO. 743 Repeated 3/68 AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, ESTABLISHING RATES FOR GARBAGE COLLECTION AND PROVIDING FOR CERTAIN INCREASED CHARGES IN THE BASIC BUSINESS RATE, RESIDENTIAL RATE, AND ESTABLISH-ING CHARGES FOR SCHOOLS, APARTMENTS AND MULTIPLE HOUSING.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. This ordinance shall not repeal the existing regulations of previous rate ordinances or change any rates in previous rate ordinances not covered herein. This ordinance shall effect an increase in the particular classifications in rates covered by it.

Section 2. The rates to be charged for the garbage collection service in the City of Kirkland shall be as follows:

Business Class 1 - \$4.60 Business Class 2 - \$2.60 Business Class 3 - \$1.60 Residential ~ \$1.40

Multiple Dwellings and Apartment Houses - \$2.50 per month plus additional can pickup charges. Each location shall be considered a separate basic unit.

Hotels - Pickups shall be daily and charged as business establishments.

Schools - Proportionate increase as set forth herein. Motels, Auto Courts, and Trailer Camps will be picked up weekly and residential rate charged for each unit. Property owner or landlord shall be charged for total services rendered. Motel or cabin court operation where the premises are rented out on a monthly basis may, at the option of the owner or operator, provide a central location, at which location owner or operator shall provide an adequate number of cans for the convenience of all tenants, in which case the premises will be charged under the apartment house rate.

In all classes and areas, and under all charges, extra cans shall be picked up at the rate of \$.15 per can per pickup.

Where it is permissible to collect rubbish for pickup in other than garbage cans, it shall be charged for as if it had been placed in such cans of regular size. Where a requested collection is of such an unusual size or at some time other than when regular collections are made at the premises, a special charge, based on the amount involved shall be made.

<u>Section 3</u>. All existing regulations, such as the number of collections per week and the various classes of garbage collection service shall be and remain unchanged by this ordinance, which is a purely <u>rate</u> ordinance.

<u>Section 4</u>. The carcasses of dogs and cats picked up by the garbage collectors shall be charged at the rate of \$1.00 each.

Section 5. The rates and provisions established in this ordinance shall be effective with the period commencing July 1, 1958.

<u>Section 6.</u> This ordinance shall be in force five days from and after its passage by the Council, approval by the Mayor, and publication according to law.
