ORDINANCE No. 744

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, AMENDING SECTION 2 OF ORDINANCE NO. 743 RELATING TO BUSINESS CLASSES AND APARTMENT HOUSE CHARGES FOR GARBAGE COLLECTION.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 743, which reads:

The rates to be charged for the garbage collection service in the City of Kirkland shall be as follows:

- Business Class 1 - \$4.60
- Business Class 2 - \$2.60
- Business Class 3 - \$1.60
- Residential - \$1.40
- Multiple Dwellings and Apartment Houses - \$2.50 per month plus additional can pickup charges. Each location shall be considered a separate basic unit.
- Hotels - Pickups shall be daily and charged as business establishments.
- Schools - Proportionate increase as set forth herein.
- Motels, Auto Courts, and Trailer Camps will be picked up weekly and residential rate charged for each unit. Property owner or landlord shall be charged for total services rendered.
- Motel or cabin court operation where the premises are rented out on a monthly basis may, at the option of the owner or operator, provide a central location, at which location owner or operator shall provide an adequate number of cans for the convenience of all tenants, in which case the premises will be charged under the apartment house rate.

In all classes and areas, and under all charges, extra cans shall be picked up at the rate of \$.15 per can per pickup.

Where it is permissible to collect rubbish for pickup in other than garbage cans, it shall be charged for as if it had been placed in such cans of regular size. Where a requested collection is of such an unusual size or at some time other than when regular collections are made at the premises, a special charge, based on the amount involved shall be made.

Shall be amended to read:

Section 2. The rates to be charged for the garbage collection service in the City of Kirkland shall be as follows:

- Business Class 1 - \$4.60
- Business Class 2 - \$2.60
- Business Class 3 - \$1.60
- Residential - \$1.40

Multiple Dwellings and Apartment Houses - Each apartment unit shall be classified as a separate dwelling unit and billed at a minimum charge of \$1.40 per month plus additional can pickup charges.

Hotels - Pickups shall be daily and charged as business establishments.

Schools - Proportionate increase as set forth herein.

Motels, Auto Courts, and Trailer Camps will be picked up weekly and residential rate charged for each unit. Property owner or landlord shall be charged for total services rendered. Motel or cabin court operation where the premises are rented out on a monthly basis may, at the option of the owner or operator, provide a central location, at which location owner or operator shall provide and adequate number of cans for the convenience of all tenants, in which case the premises will be charged under the apartment house rate.

In all three business classes extra can charges shall remain at \$.10 per can and in all other classes and areas extra cans shall be picked up at the rate of \$.15 per can per pickup.


Where it is permissible to collect rubbish for pickup in other than garbage cans, it shall be charged for as if it had been placed in such cans of regular size. Where a requested collection is of such an unusual size or at some time other than when regular collections are made at the premises, a special charge, based on the amount involved shall be made.

Section 2. Ordinance No. 743 is in all other respects confirmed.

Section 3. This ordinance shall be in force five days from and after its passage by the Council, approval by the Mayor, and publication according to law.


