## ORDINANCE NO. 747

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE RE-VISED CODE OF WASHINGTON, SECTION 35.33.090, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1958, AND APPROPRIATING THE SUM OF FIVE HUNDRED DOLLARS (\$500.00) AND AUTHORIZING THE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF PURCHASING LEDGERS, LEDGER SHEETS AND PRINTING FOR THE OFFICE OF THE CITY TREASURER IN EXCESS OF THE ESTIMATED COST OF THE EXPENSE OF THE GENERAL GOVERNMENT WHICH INCLUDES SUCH EXPENSES OF THE TREASURER'S OFFICE IN THE CITY OF KIRKLAND AND AUTHORIZING THAT SUCH EXPENDITURE BE MADE BY THE ISSUANCE OF EMERGENCY WARRANTS ON THE CURRENT EXPENSE FUND OF THE CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the welfare of the population of the City of Kirkland in that the City Treasurer's office could not be properly maintained or continued without the purchase of ledgers, ledger sheets and printing for the office of the City Treasurer and it is necessary that such purchases be made to adequately serve the needs of the citizens of Kirkland and additional funds in the amount of Five Hundred Dollars (\$500.00) are necessary to pay the expenses thereof for the balance of the fiscal year of 1958;

AND WHEREAS, the necessity of said expenditures could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year of 1958, and the appropriation therefor by the City Council, now, therefore, under the provisions of the revised Code of Washington Section 35.33.090,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of the sum of Five Hundred Dollars (\$500.00) to be used for said uses and purposes, and to enable the continuance of the records, business and operation of the office of the City Treasurer and there is hereby appropriated for the General Government of the City of Kirkland for the specified uses of purchasing ledgers, ledger sheets and printing for the office of the City Treasurer, the sum of Five Hundred Dollars (\$500.00). expenditure hereby authorized to be paid by the issuance of emergency warrants of the Current Expense Fund and that the amount of such budgets the shall be included in the 1959 budget.

This Ordinance is necessary for the preservation of the welfare of the residents and citizens of the City of Kirkland, and the maintaince and operation of the Government thereof.

Introduced the 6th day of October, 1958, an emergency declared, and this Ordinance passed and approved this 20th day of October, 1958.
