

ORDINANCE NO. 758

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING SALARIES AND WAGES OF CERTAIN CITY EMPLOYEES IN ACCORDANCE WITH THE BUDGET ADOPTED FOR 1959.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 12. This ordinance shall be in force and effect from and after its passage, approval and posting according to law.


