

ORDINANCE NO. 783

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING SALARIES AND WAGES OF CERTAIN CITY EMPLOYEES IN ACCORDANCE WITH THE BUDGET ADOPTED FOR 1960.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:


