

ORDINANCE NO. 845

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, AMENDING SECTION 5 OF ORDINANCE NO. 716 AS HERETOFORE AMENDED BY ORDINANCE No. 785, WHICH SECTION RELATES TO OCCUPATIONS SUBJECT TO TAX AND AMOUNT OF TAX IN THE CITY OF KIRKLAND, BY ADDING TO SAID SECTION 5 A NEW SUB-SECTION D, PROVIDING FOR A TEMPORARY INCREASE OF 1% OF TOTAL GROSS INCOME TO BE EFFECTIVE AUGUST 1, 1961, AND PROVIDING THAT SAID ORDINANCE NO. 716 AS AMENDED IS IN ALL OTHER RESPECTS CONFIRMED..

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That Section 5 of ORDINANCE NO. 716, as heretofore amended by ORDINANCE NO. 785, be and the same hereby is amended by the addition thereto of a new Sub-Division (D) to read as follows:

"Section 5. Occupations Subject to Tax -- Amount. There are hereby levied upon and shall be collected from the persons on account of the business activities annual license fees or occupation taxes in the amounts to be determined by the application of the rates against gross income as follows:

"(a) Upon every person engaged in or carrying on a telephone business a fee or tax equal to 2% of the total gross income from such business in the City during the fiscal year next preceding the tax year for which the license is required.

"(b) Upon every person engaged in or carrying on the business of selling or furnishing natural or manufactured gas for domestic or industrial consumption a fee or tax equal to 2% of the total gross income from such business in the City during the fiscal year next preceding the tax year for which the license is required.

"(c) Upon every person engaged in or carrying on the business of selling or furnishing electric light and power, or electrical energy, a fee or tax equal to 2% of the total gross income from such business in the City during the fiscal year next preceding the tax year for which the license is required.

"(d) Upon every person engaged in or carrying on the businesses set forth in Sub-Sections (a) through (c) inclusive, of this Section 5, in addition to the rates therein required, an additional sum which shall be equal in amount to 1% of the gross income from such business for the period from August 1, 1960 to December 1, 1960, which said additional sums shall be due and payable to the City of Kirkland in accordance with the methods of payment set forth in Ordinance No. 716, during the period from August 1, 1961 to December 31, 1961."


Section 2. That ORDINANCE NO. 716, as heretofore amended by ORDINANCE NO. 785 of the City of Kirkland be, and the same hereby is, in all other respects confirmed.

Section 3. This Ordinance shall be in force and take effect five (5) days from and after its passage by the Council, approval by the Mayor, and publication <sup>or Posting</sup> according to law, being effective as herein provided on August 1st, 1961.


