

ORDINANCE NO. 853

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, AMENDING SECTION 5 OF ORDINANCE NO. 716 WHICH SECTION RELATES TO OCCUPATIONS SUBJECT TO TAX AND AMOUNT OF TAX IN THE CITY OF KIRKLAND, BY INCREASING THE BASIC RATE FROM 2 TO 3 PERCENT OF TOTAL GROSS INCOME AND ELIMINATING FROM SAID SECTION 5 SUB-PARAGRAPH "(D)" AND REPEALING ORDINANCE NO. 845 AND PROVIDING THAT SAID ORDINANCE NO. 716 AS AMENDED IS IN ALL OTHER RESPECTS CONFIRMED.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1: That Section 5 of ORDINANCE NO. 716 be, and the same hereby is, amended to read as follows:

"Section 5: Occupations Subject to Tax -- Amount. There are hereby levied upon and shall be collected from the persons on account of the business activities annual license fees or occupation taxes in the amounts to be determined by the application of the rates against gross income as follows:

"(a) Upon every person engaged in or carrying on a telephone business a fee or tax equal to 3% of the total gross income from such business in the City during the fiscal year next preceding the tax year for which the license is required.

"(b) Upon every person engaged in or carrying on the business of selling or furnishing natural or manufactured gas for domestic or industrial consumption a fee or tax equal to 3% of the total gross income from such business in the City during the fiscal year next preceding the tax year for which the license is required.

"(c) Upon every person engaged in or carrying on the business of selling or furnishing electric light and power, or electrical energy, a fee or tax equal to 3% of the total gross income from such business in the City during the fiscal year next preceding the tax year for which the license is required."

Section 2: That ORDINANCE NO. 845 of the City of Kirkland be, and the same hereby is, repealed in toto.

Section 3: That ORDINANCE NO. 716 of the City of Kirkland be, and the same hereby is, in all other respects confirmed.

Section 4: This ORDINANCE shall be in force five (5) days from and after its passage by the Council, approval by the Mayor, and posting or publishing according to law, to take effect as herein provided, on January 1st, 1962.


