

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.080 WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORSEEN AT THE TIME OF MAKING THE BUDGET FOR 1962 AND APPROPRIATING THE SUM OF \$7,644.00 FROM THE WATER-SEWER REPLACEMENT RESERVE FUND AND AUTHORIZING THE IMMEDIATE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF PURCHASING THE TRACTOR WITH BACK-HOE ATTACHMENTS?:

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1: That, whereas an emergency exists which affects the health and welfare of the City of Kirkland in that certain equipment of the Water-Sewer Department, to-wit: a tractor with back-hoe attachments must and needs be replaced and without said equipment the City could not be properly maintained and protected, and it is necessary that said equipment be replaced and repaired and additional funds in the amount of \$7,644.00 are necessary for said replacement and repair, and whereas the necessity of said expenditures could not reasonably have been foreseen at the time of the preparation of the Budget for the Fiscal Year of 1962 and appropriation made therefor,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF KIRKLAND does hereby find that an emergency exists for the appropriation of the sum of \$7,644.00 for the purchase of a tractor with back-hoe attachments.

IT IS THEREFORE NOW HEREBY ORDAINED:

1. That the sum of \$7,644.00 be appropriated from and its expenditure is hereby authorized out of the Water-Sewer Replacement Reserve Fund for the purchase of a new tractor with back-hoe attachments, bids for which have already been called and awarded.

2. That this Ordinance shall be in force five (5) days from and after its passage by the Council, approval by the Mayor, and posting or publication according to law.

INTRODUCED this 5th day of February, 1962.


