AN ORDINANCE OF THE CITY OF KIRKLAND ADOPTING THE UNIFORM BUILDING CODE 1961 EDITION OF THE PACIFIC COAST BUILDING OFFICIALS CONFERENCE AS MODIFIED AND SUPPLEMENTED HEREIN TO BE THE BUILDING CODE OF THE CITY OF KIRKLAND, RELATING TO THE ERECTION, CONSTRUCTION, ENLARGEMENT, ALTERATION, REPAIR, MOVING, REMOVAL, CONVERSION, DEMOLITION, OCCUPANCY, EQUIPMENT, USE, HEIGHT, AREA AND MAINTENANCE OF BUILDINGS OR STRUCTURES IN THE CITY OF KIRKLAND, PROVIDING FOR THE ISSUANCE OF PERMITS, DECLARING AND ESTABLISHING FIRE DISTRICTS, PROVIDING PENALTIES FOR THE VIOLATION THEREOF, AND REPEALING ORDINANCE NO. 579.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1: That the Building Code of the City of Kirkland shall be the Uniform Building Code, 1961 Edition, Adopted by the Pacific Coast Building Officials Conference at the sixth annual meeting of October, 1927, with revisions and additions approved at the 38th Annual Meeting, September 1960, published January 1, 1961, printing of January 1, 1961, Copyright, 1961, by Pacific Coast Building Officials Conference, 124 West 4th Street, Los Angeles, California, as such 1961 Edition is hereinafter modified.

Said 1961 Edition except as it is modified and supplemented by existing City of Kirkland Ordinances No. 788 and 795, relating to fees and by Section 2 of this Ordinance below, is hereby adopted as fully and to all purposes as if set forth in full therein, and is by this reference incorporated herein, as an Ordinance of the City of Kirkland and Ordinance No. 579, together with all other Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 2: The Building Code of the City of Kirkland as adopted in Section 1 above, is hereby supplemented as follows:

A. Sliding Glass Doors Glass

~~The glass in~~ Sliding doors and sliding glass door assemblies hereafter installed in new or remodeled buildings or replaced in existing buildings, shall be one of the following:

- (a) Approved laminated safety glass nominal 7/32" or heavier
- (b) Approved nominal 7/32" or heavier wired glass.
- (c) Approved nominal 7/32" or heavier tempered glass.

B. Shower & Bathtub Enclosures

- (a) Doors and Panels. Doors and panels of shower and bathtub enclosures shall be substantially constructed from approved shatter-resistant materials. Hinged shower doors shall open outward.
- (b) Glass. Glass used in doors and panels of shower and bathtub enclosures shall be not less than nominal seven-thirty-seconds inch (7/32") in thickness and shall be an approved type of wire reinforced, tempered or laminated safety glass.
- (c) Plastics. Plastics used in doors and panels of

shower and bathtub enclosures shall be of a shatter-resistant type.

Section 3: This Ordinance shall take effect and be in force five (5) days after its passage by the Council, approval by the Mayor and posting or publishing according to law.
