

ORDINANCE No. 899

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, VACATING THAT CERTAIN PORTION OF UNOPENED LAKE AVENUE IN BLEWETT'S FIRST ADDITION TO KIRKLAND AS HEREIN DESCRIBED:

WHEREAS, by Resolution passed January 21st, 1963, the City Council of the City of Kirkland set the date of February 18th, 1963, for hearing upon the proposed vacation of a portion of that certain street known as Lake Avenue in Blewett's First Addition to Kirkland, as more fully hereinafter described, and

WHEREAS, due and proper notice of said hearing was had in accordance with law, and

WHEREAS, following said public hearing, a vote of the Council was taken favoring said vacation, and

WHEREAS, it appears desirable and to the best interest of the City and the property owners abutting thereon that said Street be vacated,

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

Section 1: That the following specifically described portion of the unopened public street situate in Kirkland, King County, Washington, and known as Lake Avenue in Blewett's First Addition to Kirkland, according to plat recorded in Volume 6 of Plats, Page 82, records of King County, described as follows, be, and the same hereby is, vacated:

BEGINNING at the southeast corner of Lot 1, Block 32, Blewett's First Addition to Kirkland, according to plat thereof recorded in Volume 6 of Plats, Page 82, records of King County, Washington; thence continuing on the easterly line of said Lot 1 as produced south 43°28'00" west, 17.54 ft; thence north 89°59'00" west along a line parallel with and 30 ft north of the produced extension of the southerly line of Block 33 of said plat, a distance of 55.90 ft to an intersection with the centerline of Lake Avenue of said plat; thence north 1°32'00" west along said centerline of Lake Avenue in said plat a distance of 208.88 ft; thence north 88°28'00" east 40.00 ft to the N.W. corner of Lot 4, Block 32 of said plat; thence south 1°32'00" east along the westerly line of said Block 32 a distance of 169.68 ft to the S.W. corner of Lot 1 of said Block 32; thence south 46°32'00" east along the southerly line of said Lot 1, a distance of 40.00 ft to the point of beginning;

Section 2: This Ordinance shall be in force and take effect five days from and after its passage by the Council, approval by the Mayor and posting or publishing in accordance with law.
