

ORDINANCE NO. 903

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.090, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1963, AND APPROPRIATING THE SUM OF Twenty-five Hundred Dollars, AND AUTHORIZING THE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF PURCHASING AN ADDITIONAL PATROL CAR FOR THE KIRKLAND POLICE DEPARTMENT, AND AUTHORIZING THE PAYMENT THEREOF BY THE EXPENDITURE OF FUNDS RECEIVED IN EXCESS OF ESTIMATED REVENUES FOR THE CURRENT EXPENSE FUND TO THE EXTENT THEREOF AND ANY DEFICIT TO BE PAID BY THE ISSUANCE OF EMERGENCY WARRANTS OF SAID CURRENT EXPENSE FUND OF THE CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the welfare of the population of the City of Kirkland in that the Kirkland Police Department cannot properly fulfill its duties with respect to traffic enforcement and maintenance of the public peace and welfare without the purchase of an additional police patrol car, and it is necessary that such purchase be made to adequately serve the needs of the citizens of Kirkland, and additional sums in the amount of \$ 2500.⁰⁰ are necessary to pay for the purchase thereof, and

WHEREAS, the necessity of said expenditure could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year 1963, and the appropriation therefore by the City Council, now, therefore, under the provisions of the revised Code of Washington, Section 35.33.090 and Section 35.383.120,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of the sum of \$ 2500.⁰⁰ to be used for the purchase of an additional police patrol car for the Kirkland Police Department, and there is hereby appropriated for said purpose the sum of \$ 2500.⁰⁰. It is further ordained that the expenditure hereby authorized be paid by the issuance of warrants drawn upon the Current Expense Fund and chargeable against funds

received by said Current Expense Fund in excess of estimated revenues to the extent of such excess revenues. In the event such excess revenues shall not be sufficient, the deficit shall be paid by emergency warrants drawn upon the Current Expense Fund and the amount of such emergency warrants shall be included in the budget for the fiscal year 1964.


This Ordinance is necessary for the preservation of the welfare of the residents and citizens of the City of Kirkland, and the maintenance and operation of the Government thereof.

INTRODUCED the ^{16th day of May} ~~15th day of April~~, 1963, an emergency declared, and this Ordinance Passed and Approved this ^{20th} ~~5th~~ day of May, 1963.
