

ORDINANCE NO. 922

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, ESTABLISHING SALARIES AND WAGES OF CERTAIN CITY EMPLOYEES AND OFFICIALS IN ACCORDANCE WITH THE BUDGET ADOPTED FOR THE YEAR 1964.
