

ORDINANCE NO. 932

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.090, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1964, AND APPROPRIATING THE SUM OF \$500.00, AND AUTHORIZING THE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF ALLOWING THE CITY OF KIRKLAND PLANNING COMMISSION TO COMPLETE PRINTING, PUBLICATION, RECORDING AND FILING OF THE CITY OF KIRKLAND COMPREHENSIVE PLAN, BOTH TEXT AND MAP, AND TO FURTHER PERMIT THE PLANNING COMMISSION TO MAKE CERTAIN IMMEDIATE STUDIES AND SURVEYS IN REGARD TO MULTIPLE HOUSING, DENSITY AND WATERFRONT PROBLEMS RELATING TO ZONING, AND AUTHORIZING THE PAYMENT THEREOF BY THE EXPENDITURE OF FUNDS RECEIVED IN EXCESS OF ESTIMATED REVENUES FOR THE CURRENT EXPENSE FUND TO THE EXTENT THEREOF, AND ANY DEFICIT TO BE PAID BY THE ISSUANCE OF EMERGENCY WARRANTS OF SAID CURRENT EXPENSE FUND TO THE CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

WHEREAS, an emergency exists that affects the welfare of the population of the City of Kirkland, in that the Kirkland Planning Commission cannot properly fulfill its duties with respect to completion of printing, publication, recording and filing of the recently adopted comprehensive plan, both text and maps, and to make certain immediate studies and surveys as to multiple housing, density, and waterfront problems related to zoning, and it is necessary that such work be completed and such studies and surveys be immediately undertaken in order to adequately serve the needs of the citizens of Kirkland, and an additional sum in the amount of \$500.00 is necessary to pay therefor, and

WHEREAS, the necessity of said expenditures could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year 1964, and the appropriation therefor by the City Council,

NOW, THEREFORE, under the provisions of the Revised Code of Washington, Section 35.33.090, and Section 35.38.120, the City Council of the City of Kirkland does hereby find that an emergency exists for the appropriation of the sum of \$500.00 to be used by the City of

Kirkland Planning Commission for the completion of printing, publication, recording and filing of the City of Kirkland Comprehensive Plan, both text and map, and for the immediate commencement of study and surveys relating to multiple housing, density and waterfront in connection with zoning, and there is hereby appropriated for said purposes the sum of \$500.00.

IT IS FURTHER ORDAINED that the expenditures hereby authorized be paid by the issuance of warrants drawn upon the current expense fund and chargeable against funds received by said current expense fund in excess of estimated revenues to the extent of such excess revenues. In the event such excess revenues shall not be sufficient, the deficit shall be paid by emergency warrants drawn upon the current expense fund, and the amount of such emergency warrants shall be included in the budget for the fiscal year 1965.

This ordinance is necessary for the preservation of the Welfare of the residents and citizens of the City of Kirkland and the maintenance and operation of the government thereof.

INTRODUCED the 2nd day of March, 1964.
