AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.090, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1964, AND APPROPRIATING THE SUM OF \$1,000.00, AND AUTHORIZING THE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF CONDUCTING A USE STUDY AND SURVEY OF THE KIRKLAND CIVIC CENTER AREA, INCLUDING THE DETERMINATION OF A LOCATION WITHIN SAID AREA OF A NEW PROPOSED LIBRARY BUILDING, AND AUTHORIZING THE PAYMENT OF SAID SUM BY EXPENDITURE OF FUNDS RECEIVED IN EXCESS OF ESTIMATED REVENUES FOR THE CURRENT EXPENSE FUND TO THE EXTENT THEREOF, AND ANY DEFICIT TO BE PAID BY THE ISSUANCE OF EMERGENCY WARRANTS OF SAID CURRENT EXPENSE FUND TO THE CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

WHEREAS, an emergency exists that affects the welfare of the population of the City of Kirkland in that there has been placed before the voters of said city for their determination on November 3, 1964, a library bond issue which provides for construction of a new library building within the civic center area, and

WHEREAS, in order to properly determine a location for such building within the civic center area, it is necessary that a use study and survey be made of the entire civic center area; and it is necessary that such study and survey be immediately undertaken in order to adequately serve the needs of the citizens of Kirkland, and a sum in the amount of \$1,000.00 which has not been heretofore appropriated is necessary to pay therefor, and

WHEREAS, the necessity of said expenditure could not reasonably have been foreseen at the time of the budget for the fiscal year 1964 and the appropriation therefor by the City Council,

NOW, THEREFORE, under the provisions of the Revised Code of Washington, Section 35.33.090, Section 35.38.120, the City Council of the City of Kirkland does hereby find that an emergency exists for the appropriation of the sum of \$1,000.00 to be used by the City of Kirkland in the conduct of a use plan and survey of the City of Kirkland Civic Center area, and there is hereby appropriated for said purpose the sum of \$1,000.00.

be paid by the issuance of warrants drawn upon the current expense fund and chargeable against funds received by said current expense fund in excess of estimated revenues to the extent of such excess revenues. In the event such excess revenues shall be insufficient, the deficit shall be paid by emergency warrants drawn upon the current expense fund and the amounts shall be included in the budget for the fiscal year 1965. That so much of the cost of said survey as can upon its completion be properly allocated as representing a benefit accruing to the City of Kirkland Park Department and the City of Kirkland library shall be considered a loan by said current expense fund to said park and library funds, and the current expense fund shall be reimbursed therefor.

This ordinance is necessary for the preservation of the welfare of the residents of the City of Kirkland, and the maintenance and operation of the government therefor.

INTRODUCED the 14th day of September, 1964.

EMERGENCY DECLARED, and this ordinance passed and approved the 21st day of September, 1964.
