ORDINANCE NO. 957

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, RELATING TO THE PUBLIC SAFETY AND WELFARE, AMENDING SECTION 805 OF CHAPTER 8 OF ORDINANCE 895 OF THE CITY OF KIRKLAND, THE CITY OF KIRKLAND PENAL ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND AS FOLLOWS:

Section 1. That Section 805 of Chapter VII of Ordinance No. 895 of the City of Kirkland be, and it hereby is, amended to read as follows:

"Section 805. Disorderly Conduct. It shall be unlawful for any person to conduct himself in a disorderly manner. The following shall be deemed disorderly persons and guilty of a violation of this section:

- (1) any person intoxicated in a public place;
- (2) any person fighting or quarreling in a public place;
- (3) any person who takes an automobile without permission of the owner;
- (4) any person who shall resist or interfere with a police officer in the performance of his duty or refuse to aid him when called upon;
- (5) any person acting in a noisy, riotous, or tumultuous way in city;
- (6) any person using vulgar, profane, obscene or indecent language in the presence of another person;
- (7) any male who shall molest, annoy, bother, or insult female person;
- (8) any person wandering or loitering;
- (9) any person wandering or loitering at late hour of night;
- (10) any person with no means of support who does not seek employment or work when offered employment;
- (11) any person practicing phrenology, hypnotism, mesmerism, fortune telling, palmistry, clairvoyance, astrology reading, except hypnotism used by licensed doctor or dentist;
- (12) any person who drives in reckless manner or improper manner;
- (13) any person who destroys property of another;
- (14) any person who removes property for purpose of annoyance or mischief;
- (15) any person carrying concealed weapon capable of inflicting injury;
- (16) any person who uses deadly weapon to intimidate another person;
- (17) any person firing gun, bomb, or other firearm in city in unlawful manner;
- (18) any person using force or violence on person of another;
- (19) any person placing object not securely fastened upon window sill or outside portion of building in position above street or sidewalk;

- (20) any person taking or stealing property of \$75 value or less;
- (21) any person soliciting alms in city;
- (22) any person practicing homosexuality or prostitution;
- (23) any person who shall cohabit with another, not the husband or wife of such person;
- (24) any person who shall make any indecent or obscene exposure;
- (25) any male person living upon earnings of prostitute;
- (26) any person who lives, works, or is found in house of prostitution, or who associates with or solicits for any prostitute;
- (27) any person found associating with drunken person in manner to create suspicion of intent to rob person;
- (28) any person maintaining any gambling device in city;
- (29) any person engaged in purpose of swindling or defrauding others;
- (30) any person engaged in performance or exhibition of obscene, indecent, or immoral show, act or performance in city;
- (31) any person engaged in narcotic distribution and person using such narcotics;
- (32) any person who is habitual user of narcotics;
- (33) any person who buys or sells stolen property with knowledge that property is stolen;
- (34) any person found intoxicated in motor vehicle in city;
- (35) any person obtaining food, lodging or accommodation in hotel, apartment house, restaurant, cafe, boarding or lodging house without paying therefor;
- (36) any person who shall conduct himself in a manner which tends to or does disturb the public peace, provoke disorder, or endanger the safety of others;

Any person who shall violate any provision of this section shall be guilty of a misdemeanor."

Section 2. That Ordinance No. 895 of the City of Kirkland, the Kirkland Penal Ordinance, is in all other respects ratified and confirmed.

Section 3. This ordinance shall be in full force and take effect five (5) days from and after its passage by the council, approval by the Mayor, and posting or publishing as required by law.
