

ORDINANCE NO. 967

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING ORDINANCE NO. 909 OF THE CITY OF KIRKLAND ADOPTED AUGUST 5, 1963, AND MAKING CERTAIN TECHNICAL CORRECTIONS IN THE LEGAL DESCRIPTION OF THE AREA ANNEXED TO THE CITY OF KIRKLAND BY VIRTUE OF ORDINANCE NO. 909.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND AS FOLLOWS:

WHEREAS, the written legal description of the area annexed to the City of Kirkland on the 5th day of August, 1963, by virtue of Ordinance No. 909 of the City of Kirkland contained a scrivener's error in that the North half of that portion of N.E. 100th annexed to the City of Kirkland in said Ordinance No. 909 is in Section 32, Township 26 North, Range 5 E.W.M., King County, Washington, rather than in Section 5, Township 25 North, Range 5 E.W.M., King County, Washington,

NOW, THEREFORE:

Section 1. Section 1 of Ordinance No. 909 of the City of Kirkland adopted the 5th day of August, 1963, be and it hereby is amended to read as follows:

"Section 1. That certain territory situate in King County Washington, lying contiguous to the present boundaries of the City of Kirkland, and described as follows, to-wit:

Starting at the monument at the northeast corner of Lot 1, Block 1, of the Lake Avenue Addition to Kirkland; thence North 89°18'06" East a distance of 8 feet to the point of beginning; thence South 2°39'00" East a distance of 460 feet to the center line of N.E. 98th Street; thence South 86°46'15" West along said center line a distance of 277.6 feet to the center line of the alley between Blocks 7 and 8; thence North 3°13'45" West along said center line for a distance of 316 feet to the center line of N.E. 99th Street; thence North 86°46'15" East along said center line for a distance of 128 feet to the southerly extension of the West line of Lot 5, Block 1; thence North 3°13'45" West along said West line extended and West line for a distance of 175 feet to the North line of N.E. 100th Street; thence North 89°18'06" East along said North line for a distance of 142.2 feet; thence South 2°39'00" West for a distance of 30 feet to the point of beginning, comprising Lots 1 to 5 inclusive, Block 1 and Lots 1 to 18 inclusive, Block 2, Lake Avenue Addition to Kirkland. All in the northeast quarter of

Section 5, Township 25 North, Range 5 E.W.M., EXCEPT that portion of N.E. 100th Street, which is in the southeast quarter of Section 32, Township 26 North, Range 5 E.W.M., King County, Washington;

be and the same hereby is annexed to the City of Kirkland and made a part thereof."


Section 2. That said Ordinance No. 909 be in all other respects, ratified and confirmed.

Section 3. This ordinance shall be in force and take effect 5 days from and after its passage by the Council, approval by the Mayor, and posting or publishing according to law.


