

ORDINANCE NO. 977

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO CAPITAL IMPROVEMENTS, AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS WITH THE STATE HIGHWAY DEPARTMENT AS TO ALLOCATION OF COSTS OF CONSTRUCTION AND REPLACEMENT OF WATER AND STORM SEWER LINES ON CENTRAL WAY IN CONNECTION WITH THE NEW CONSTRUCTION ON SSH 2-D, AND PROVIDING FOR PAYMENT OF THE CITY'S COST OBLIGATIONS THEREUNDER.

WHEREAS, pursuant to Ordinance No. 941 of the City of Kirkland, the City did enter into a contract with the State Highway Department for finance and construction of relocated Secondary State Highway 2-D within the city limits of the City of Kirkland between State Highway 405 and Lake Street, and

WHEREAS, the construction planned under said ordinance requires the construction of combined state and city storm sewer facilities and relocation of water line facilities within and adjacent to the State Highway right of way, and

WHEREAS, it is deemed to be in the best public interest for the state to include the necessary items of work for constructing said facilities in the state construction contract proposed for the improvements of this section of state highway, and that the City of Kirkland shall reimburse the State Highway Department and the State of Washington for its portion of the costs of such facilities,

NOW, THEREFORE, be it ordained by the City Council of the City of Kirkland as follows:

Section 1. The Acting City Manager is hereby authorized to execute on behalf of the City of Kirkland those certain contracts with the Washington State Highway Commission attached hereto as Exhibits "A" and "B".

Section 2. In order to reimburse the State of Washington, Washington State Highway Commission as in said contracts provided, expenditures within the 1965 budget for the City of Kirkland as follows are hereby authorized to be paid out of the following funds:

(a) Water-sewer replacement reserve fund - \$12,115.80

(b) (1) Arterial street fund - \$36,847.76  
 (2) General street fund - \$12,282.58

Section 3. The City Clerk in consultation with the City Manager is hereby authorized to make such budgetary transfers in the 1965 budget between Street Department classifications as to maintenance and operation items and capital improvement items as may be necessary to conform the 1965 budget with the general street fund expenditures herein authorized.

Section 4. This ordinance shall be in force and take effect 5 days from and after its passage by the Council, approval and publication as required.
