# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND ADOPTING AMENDED PET LICENSE FEES AND PENALTIES.

WHEREAS, the City of Kirkland has enacted ordinances to authorize the creation of an Animal Control Authority in the City and allow the City to provide its own animal services within its boundaries, including animal licensing, care and control, as of January 1, 2018; and

WHEREAS, on August 2, 2017, the City Council passed Ordinance 4592, Section 5, codified as Kirkland Municipal Code (KMC) 8.09.150, authorizing the City Council to establish and amend animal services fees and fines by resolution; and

WHEREAS, on August 2, 2017, Council adopted Resolution R-5262, setting forth the City's initial Pet License Fees and Penalties Schedule in Exhibit A attached to R-5262; and

5 Whereas, Council has determined that several corrections need 6 to be made to the City's Pet Licenses Fees and Penalties schedule before 7 the City's animal services authority becomes effective on January 1, 8 2018, in the manner set forth in Exhibit A attached hereto.

NOW, THEREFORE, be it resolved by the City Council of the City
 of Kirkland as follows:

<u>Section 1</u>. The Kirkland Police Department Animal Control Authority Pet License Fees and Penalties Schedule Amended November 2017, attached as Exhibit A hereto, is approved.
