

ORDINANCE NO. 991

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO THE KIRKLAND VOLUNTEER FIRE DEPARTMENT AND REPEALING ORDINANCE NO. 529.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. The City of Kirkland does hereby subscribe to Chapter 41.24 of the Revised Code of Washington, Volunteer Firemen's Relief and Pension, for the creation of death and disability insurance protection for the members of the volunteer fire department of the City of Kirkland and does further subscribe to subsection 2, RCW 41.24.020, whereby any fireman may enroll under the pension provisions of Chapter 41.24, Revised Code of Washington, for the purpose of enabling any fireman so electing to avail himself of the retirement provisions of said chapter.

Section 2. The City Treasurer in and for the City of Kirkland is hereby directed to pay annually on or before the 1st day of March of each year to the State Treasurer in and for the State of Washington a sum equal to the total amount of \$5.00 for each member of the Kirkland Volunteer Fire Department for the payment of the annual premium as to death or disability benefits under said chapter. The City Treasurer of the City of Kirkland is hereby directed to remit annually to the State Treasurer for the State of Washington the annual fee of \$22.00 for each Kirkland volunteer fireman electing to enroll and avail himself of the retirement provisions of RCW Chapter 41.24, \$10.00 of which annual fee shall be paid by the City of Kirkland, and \$12.00 of which shall be paid by the fireman. Unless an electing fireman files with the City Clerk in writing provision for payment of his contribution in a different manner, the Clerk is authorized and directed to withhold the individual fireman's contribution from his salary.

Section 3. There is hereby created a board of trustees of the City of Kirkland Fire Department for the purpose of administering the provisions of this ordinance pursuant to the requirements of Chapter 41.24, Revised Code of Washington, which said board of trustees shall consist of the mayor, the city clerk, one councilman, the chief of the fire department and one member of the fire department to be elected by the members of the fire department for a term of one year and annually thereafter. The mayor is hereby designated as chairman of said board of trustees and the clerk is hereby designated as secretary of said board, and the treasurer thereof. It shall be the duties of said board of trustees to carry out the provisions of Chapter 41.24, Revised Code of Washington.

Section 4. Any member of the City of Kirkland Volunteer Fire Department for whom the annual retirement fee of \$22.00 has heretofore been paid in the manner prescribed in Section 2 of this ordinance shall be deemed to have elected to avail himself of the retirement provisions of RCW Chapter 41.24, as of the date of the first payment of such annual fee.

Section 5. Ordinance No. 529 of the City of Kirkland be and it hereby is repealed in toto.

Section 6. This ordinance shall be in force and take effect five days from and after its passage by the council and publication as required.
