

ORDINANCE NO. 10290

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN THE REVISED CODE OF WASHINGTON, SECTION 35.33.090, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1966, AND APPROPRIATING THE SUM NOT TO EXCEED \$3,000.00, AND AUTHORIZING THE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF MAKING CERTAIN REPLACEMENTS, REPAIRS AND IMPROVEMENTS AT THE CIVIC CENTER COMPLEX, INCLUDING REPLACEMENT OF THE WOODEN FENCE AROUND THE BALL PARK, AND AUTHORIZING THE PAYMENT THEREOF, THROUGH THE ISSUANCE OF EMERGENCY WARRANTS AND/OR INTERNAL BORROWING.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

WHEREAS, an emergency exists that affects the welfare of the population of the City of Kirkland in that certain repairs and improvements at the Civic Center complex are required immediately including replacement of the wood fence around the ball park and other repairs and improvements to the grandstand and grounds, and

WHEREAS, the necessity of such expenditures could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year 1966 and the appropriation therefor by the City Council,

NOW, THEREFORE, under the provisions of the Revised Code of Washington, Section 35.33.090 and Section 35.33.120, the City Council of the City of Kirkland does hereby find that an emergency exists for the appropriation of the sum of not to exceed \$3,000.00 to be used by the City of Kirkland in the immediate repair, replacement and improvement of the ball park facilities at the Civil Center complex, including the replacement of the wooden fence and other repairs and improvements, and there is hereby appropriated for said purposes the sum of not to exceed \$3,000.00.

It is further ordained that the expenditures hereby authorized be paid by the issuance of emergency warrants, or by

borrowing from excess funds on hand in any available city funds, or any combination thereof, and the amounts of such emergency warrants and provision for repayment of such loans shall be included in the budget for the fiscal year 1967.

This ordinance is necessary for the preservation of the welfare of the residents and citizens of the City of Kirkland and the maintenance and operation of the government thereof.

INTRODUCED at regular meeting on the 7th day of March, 1966, an emergency declared and this ordinance adopted by majority vote of the City Council in regular meeting on March 14, 1966.
