AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, RELATING TO AND REGULATING MOTOR VEHICLES, TRAFFIC, TRAVEL AND TRANSPORTATION AND THEIR INCIDENCE UPON THE PUBLIC STREETS, BICYCLE PATHS AND OTHER WAYS OPEN TO THE PUBLIC AND AMENDING ORDINANCE NO. 956.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND AS FOLLOWS:

Section 1. Section 29 of Ordinance 956 is hereby amended by adding thereto a new sub-section to be known as Sub-section 29B to read as follows:

"SECTION 29B. Decrease of state speed limit on state highways.

It is hereby determined upon the basis of engineer and traffic investigation that the speed permitted by state law on the following state highways within the corporate limits is greater than is reasonable under the conditions found to exist on such highways and it is hereby declared that a reasonable and safe speed limit is

Section 2. Section 91 of Ordinance 956 is hereby amended to read as follows:

"Section 91. Penalties. Unless another penalty is expressly provided by law every person convicted of a violation of any provision of this Ordinance shall be punished by a fine of not more than \$500.00 or by imprisonment for not more than 180 days or by both such fine and imprisonment.

Section 3. Section 105 of Ordinance 956 is hereby amended to read as follows:
