

ORDINANCE NO. 1056

AN ORDINANCE OF THE CITY OF KIRKLAND, AMENDING THE COMPREHENSIVE PLAN MAP OF THE CITY OF KIRKLAND AS ADOPTED IN ORDINANCE NO. 930 TO INCLUDE THEREIN SUBSEQUENTLY ANNEXED TERRITORY.

WHEREAS, the Kirkland Planning Commission after public hearing thereon held on the 6th day of October, 1966, has recommended to the Kirkland City Council that the Comprehensive Plan Map for the City of Kirkland be amended to include the territories annexed to the City of Kirkland subsequent to the adoption of the Kirkland Comprehensive Plan, and,

WHEREAS, the City Council of the City of Kirkland did hold on the 7th day of November, 1966, a public hearing to consider said recommendation and following said hearing did concur in the recommendation of the Kirkland Planning Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND AS FOLLOWS:

Section 1. The Comprehensive Plan Map of the City of Kirkland adopted as part of the Comprehensive Plan for the City of Kirkland by Ordinance No. 930, is hereby amended to include the areas encircled on the map attached to this Ordinance and by this reference incorporated herein which said areas were annexed to the City of Kirkland subsequent to the adoption of Ordinance No. 930.

Section 2. The recommended land use for each of said encircled areas in accordance with the principals embodied in the Comprehensive Plan of the City of Kirkland shall be as indicated on the attached map.

Section 3. A certified copy of said map shall be filed with the King County Auditor and with the City Clerk.

Section 4. This Ordinance shall take effect five days following and after its passage by the Council and publication as required.

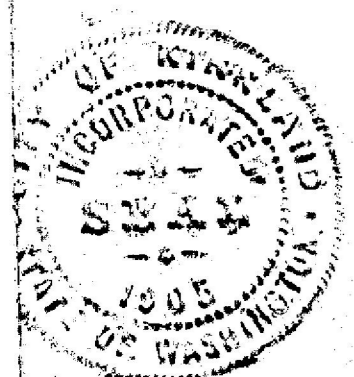
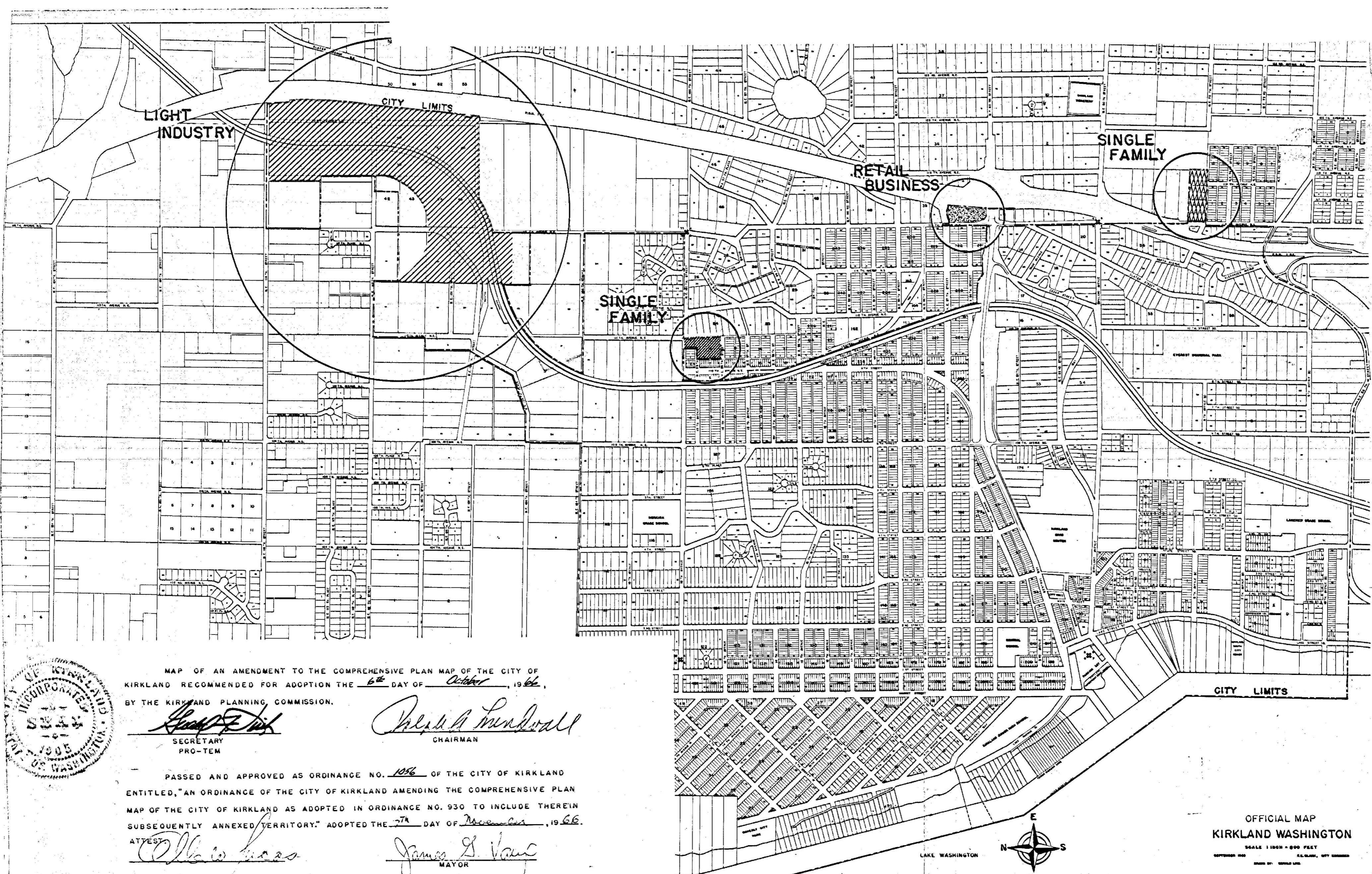
