

ORDINANCE NO. 1064

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN RCW SECTION 35.33.090 WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1967, PROVIDING FOR THE PAYMENT OF CERTAIN SALARIES IN EXCESS OF, AND IN ADDITION TO THE SALARIES PROVIDED BY THE 1967 BUDGET ESTABLISHING THE SALARY FOR THE PLANNING DIRECTOR, AUTHORIZING THE EXPENDITURE OF SUMS NECESSARY FOR THE PAYMENT OF SAID SALARY AND SALARY INCREASES APPROPRIATING SAME:

The City Council of the City of Kirkland do ordain as follows:

WHEREAS, an emergency exists that affects the welfare of the population of the City of Kirkland, in that the expanding economy of Western Washington has resulted in increased municipal problems and,

WHEREAS, in order to properly plan and provide for economic and population growth in the year 1967 and thereafter, it is necessary that the City obtain and retain qualified, experienced personnel, and

WHEREAS, the salaries as provided by the 1967 budget when adopted in October, 1966, as to certain hereinafter specified positions including the newly created position of Planning Director are not adequate in the light of the salary levels <sup>now</sup> to be prevailing in other Western Washington municipalities during 1967, and further are not adequate to maintain present qualified experienced personnel, and

WHEREAS, an emergency exists which could not reasonably have been foreseen at the time of the preparation of the budget for the fiscal year 1967, and the appropriation therefor by the City Council,

NOW, THEREFORE, under the provisions of RCW Section 35.33.090, and Section 35.33.120, <sup>and</sup> the City Council of the City of Kirkland does hereby <sup>find</sup> the existence of an emergency and declares same, and hereby appropriates and authorizes the expenditure of the sums hereinafter set forth for salaries as to individual positions hereinafter enumerated.

Section 2. The salaries and wages of the following designated city officials and employees of the City of Kirkland are hereby established to be effective as of

January 1, 1967, except as to that portion thereof indicated to become effective as of July 1, 1967. The time during the year 1967 when any increase hereinafter provided for as to any one official or employee shall become effective shall be at the discretion of the City Manager.

Section 8. It is further ordained that the expenditures hereby authorized be paid from excess monies on hand in the appropriate fund, or by the issuance of emergency warrants or by borrowing from excess funds on hand in any available city fund, or any combination thereof, and the amounts of such emergency warrants and provision for payment of such loan shall be included in the budget for the fiscal year, 1968. This Ordinance is necessary for the preservation of the welfare of the residents and citizens of the City of Kirkland and the maintenance and operation of the government thereof.

Introduced at regular meeting on the 3rd day of January, 1967, an emergency declared and this Ordinance adopted by a majority vote of the City Council in regular meeting on the sixteenth day of January, 1967.
