ORDINANCE No. 1078

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, RELATING TO ARTERIAL STREETS, DESIGNATING ARTERIAL STREETS FOR THE CITY OF KIRKLAND, ADOPTING THE REVISED SIX-YEAR PROJECT PROGRAM FOR ARTERIAL STREET IMPROVEMENT; AND SUPPLEMENTING THE COMPREHENSIVE PLAN OF THE CITY, AS PROVIDED IN ORDINANCE NO. 930.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. The following streets of the City of Kirkland are hereby designated primary arterial streets:

Section 4. Pursuant to RCW, Chapter 35.77, the six-year arterial street improvement program of the City of Kirkland, is revised and adopted as set forth in Exhibit A to this ordinance, which exhibit by this reference, is incorporated herein. A copy of said program, together with this ordinance, shall be filed with the Director of Highways for the State of Washington as required by law.

Section 5. All arterial streets shall have mercury vapor lighting for better traffic control. Traffic control lights to be installed at all major intersections.,

Section 6. As provided in Ordinance No. 930, Adopting the Comprehensive Plan for the City of Kirkland, the arterial street portion of the Comprehensive Plan is hereby supplemented.

Section 7. This ordinance shall be in force and take effect five (5) days from and after its passage by the Council and publication as required by law.
