

ORDINANCE No. 1085

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, AMENDING THE COMPREHENSIVE PLAN MAP OF THE CITY OF KIRKLAND AS ADOPTED IN ORDINANCE NO. 930.

WHEREAS, the Kirkland Planning Commission, after public hearing thereon, held April 6, 1967, has recommended to the Kirkland City Council that the Comprehensive Plan Map for the City of Kirkland be amended as hereinafter set forth, and

WHEREAS, the City Council of the City of Kirkland did hold on the 17<sup>th</sup> day of July, 1967, a public hearing to consider said recommendation, and following said hearing did concur in the recommendation of the Kirkland Planning Commission,

NOW, THEREFORE, Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. The Comprehensive Plan Map of the City of Kirkland, as adopted as a part of the Comprehensive Plan for the City of Kirkland by Ordinance No. 930, is hereby amended as to the areas of the City of Kirkland circled on the map attached to this Ordinance, which map by this reference is made a part hereof. The areas so circled appear on the original of the Comprehensive Plan Map to be recommended for manufacturing use, and said recommendation is hereby changed to the uses recommended and shown on the attached map.

Section 2. The City Manager is hereby directed to cause this Ordinance and the map attached hereto to be certified and filed with the City Clerk, and with the King County Auditor in the manner required by law.

Section 3. This Ordinance shall take effect five (5) days from and after its passage by the Council, and

publication as required.

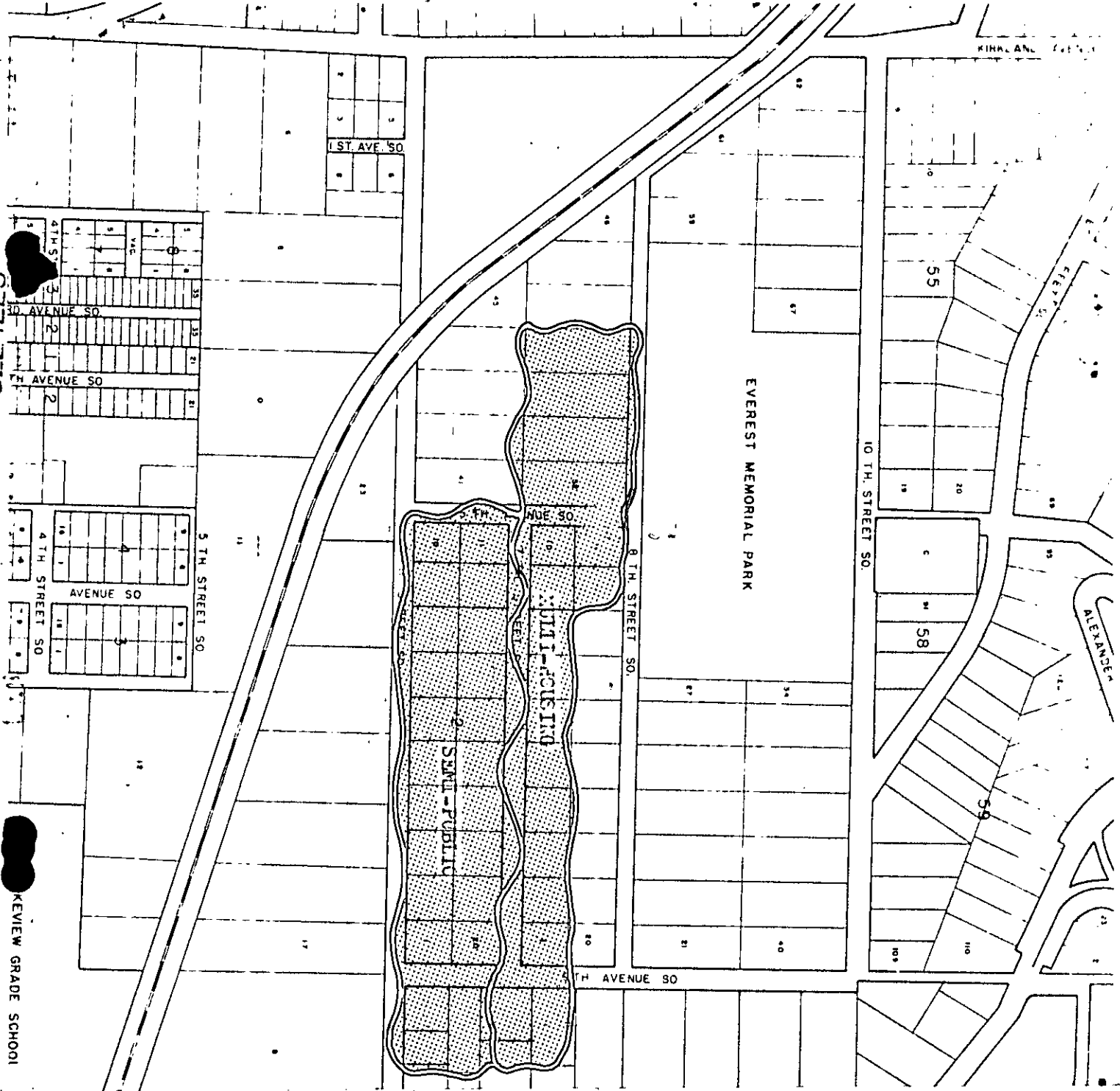
