

ORDINANCE NO. 1124

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, ADOPTING A PLAN FOR THE ACQUISITION, CONSTRUCTION AND INSTALLATION OF CERTAIN ADDITIONS AND IMPROVEMENTS TO AND EXTENSIONS OF THE COMBINED WATER AND SEWERAGE SYSTEM OF THE CITY, DECLARING THE ESTIMATED COST THEREOF AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$2,000,000 OF WATER AND SEWER REVENUE BONDS OF THE CITY TO PROVIDE FUNDS TO PAY SUCH COST.

WHEREAS, the City of Kirkland, Washington, now owns, maintains and operates a combined water and sewerage system, which system is in need of certain additions, improvements and extensions; and

WHEREAS, in order to provide the funds necessary to pay the cost of acquiring, constructing and installing such additions, improvements and extensions it is deemed necessary and advisable that the city issue and sell its water and sewer revenue bonds in the total principal sum of \$2,000,000.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kirkland, Washington, as follows:

Section 1. The following plan of improvement to the combined water and sewerage system of the city are hereby specified and adopted, to wit:

A. The city shall acquire, construct and install the following described pump stations, meters, waterlines and sewer mains, on, along and under the following described streets, avenues, easements and rights of way:

Said improvements shall be completed with all necessary and proper facilities and appurtenances.

The City shall acquire all real and personal property, rights-of-way, franchises and easements necessary to carry out said plan.

The City Council may make such changes in the details of said plan, either prior to or in the actual course of construction, which may be found necessary and desirable as long as same do not substantially affect or change the general parts of said plan as above set forth.

Section 2. The estimated cost of the acquisition, construction and installation of the additions and improvements to and extensions of the water and sewerage system of the city as set forth in Section 1 above is hereby declared to be, as near as may be, the sum of \$2,000,000 which cost shall be paid from the sale of water and sewer revenue bonds of the city.

Section 3. As an integral part of the plan for acquiring, constructing and installing such additions and improvements to and extensions of the water and sewerage system of the city, the city shall issue and sell its water and sewer bonds in the total principal sum of not to exceed \$2,000,000. Said bonds shall be sold in such amount or amounts and at such time or times as the Council may determine to be to the best interest of the city. The exact date or dates, form, terms, maturities and covenants of such bonds shall be as hereafter fixed by ordinance or ordinances of the city.

Section 4. This ordinance shall become effective five days after its passage, approval and publication as provided by law.
