

ORDINANCE NO. 1141

AN ORDINANCE OF THE CITY OF KIRKLAND, RELATING TO ARTERIAL STREETS, FINDING THE NECESSITY TO INCREASE THE IMPROVED WIDTH OF CERTAIN STREETS, AND ORDERING THE WORK THEREFORE TO BE DONE AT THE EXPENSE OF THE CITY OF KIRKLAND.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. The streets as described and identified in Section 2 of this Ordinance have heretofore been ordered to be improved to the minimum width indicated (face of curb to face of curb) as part of an improvement project to be financed by Local Improvement District No. 100, created in Ordinance No. 1106. Based upon engineering, planning and traffic studies prepared for the City of Kirkland, it is now hereby found necessary to increase the width of said streets (face of curb to face of curb) to the maximum widths set forth in Section 2 below. The work necessary to improve the additional width of said streets is hereby ordered as a separate project and the cost of such separate project shall be borne by the City of Kirkland.

Section 2.- The following described streets shall be increased in width, face of curb to face of curb, as herein indicated and such increased width shall be improved by grading, by ballasting as necessary with crushed rock base course, and by bituminous surfacing all according to plans and specifications now on file in the office of the City Engineer, which plans and specifications are by this reference approved:

Section 3. This ordinance shall be in force and take effect five (5) days from and after its passage by the Council and publication as required by law.
