

ORDINANCE NO. 1151

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, SUPPLEMENTING THE PLAN FOR ACQUISITION, CONSTRUCTION AND INSTALLATION OF CERTAIN ADDITIONS AND IMPROVEMENTS TO, AND EXTENSIONS OF, THE COMBINED WATER AND SEWERAGE SYSTEM OF THE CITY OF KIRKLAND AS ADOPTED IN ORDINANCE NO. 1124 OF THE CITY OF KIRKLAND, AND PROVIDING FOR THE CONSTRUCTION OF SAID WATER AND SEWER FACILITIES.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. The plan for the acquisition, construction and installation of certain additions and improvements to, and extensions of the combined water and sewerage system of the City of Kirkland, adopted pursuant to Ordinance No. 1124, is hereby supplemented and the following additional improvements and projects are added to said plan:

a. The City shall acquire, construct and install the following described pump stations, meters, water lines and sewer mains on, along and under the following described streets, alleys, easements and right-of ways:
