

ORDINANCE NO. 2018

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON RELATING TO BUILDINGS AND STRUCTURES: AND SUPPLEMENTING AND AMENDING THE PLUMBING CODE FOR THE CITY OF KIRKLAND AS ADOPTED IN CHAPTER IV OF ORDINANCE NO: 1140.

Be it Ordained by the City Council of the City of Kirkland as follows:

Section 1. Chapter IV, entitled Plumbing, of Ordinance No. 1140, of the City of Kirkland adopted April 15, 1968, is hereby supplemented and amended to read as follows:

Chapter IV: Plumbing

Section 4.1 the plumbing code for the City of Seattle, King County, in the form issued by the Seattle, King County Department of Public Health and published by Book Publishing Company, together with King County resolution No. 34798 entitled, "A Resolution Relating to and Regulating Plumbing and Plumbing Systems; amending resolution No. 28817 as amended by resolution No. 32650", together with amendments, thereto, hereafter made, are hereby adopted by this reference to be the plumbing code for the city of Kirkland.

Section 4.2 the plumbing code adopted by reference in Section 4.1 above is hereby amended and supplemented as follows:

Section 5.01.050 the CITY CONTROLLER shall mean the Director of Administration and Finance (Ex-officio City Clerk) for the City of Kirkland, his deputy or other authorized representative.

Section 5.01.060 DIRECTOR OF PUBLIC HEALTH, for the purposes of enforcement of the plumbing code, shall mean the building department administrator for the City of Kirkland or his authorized representative.

Section 5.01.320 (b) Appointment Term. Members of the Plumbing Advisory Board, other than Ex officio, shall be appointed by the City Manager and vacancies among such members shall be filled in the same manner. Upon naming of the appointive members of the board, the City Manager shall designate one such member to a term ending, December 31, 1969, one such member to a term ending, December 31, 1970, one such member to a term ending,

(Section 5.01.320 (b) continued) one such member to a term ending, December 31, 1971, one such member to a term ending December 31, 31, 1973. Thereafter such members shall be appointed for a term of five years ending, December 31, of the 5th year of said term.

Section 5.01.370 JOURNEYMAN'S LICENSE. Until such time as the City of Kirkland establishes licensing procedures for journeymen, including the establishment of a City of Kirkland examination board, the City of Kirkland will recognize and honor only those licenses issued by King County as to journeymen plumbers and journeymen lawn sprinkler mechanics. It shall be unlawful to do any work for which a plumbing permit is required without a journeymen's license for such purpose as required by this Chapter except as follows:

1. An apprentice may do work on a plumbing system under the direct supervision and immediate presence of a holder of a journeymen's license to do such work.

2. A resident owner may personally do work on a plumbing system in his own Single Family residence or usual accessory building.

Section 5.01.380 (a) EXAMINATION BOARD. The City Manager is hereby authorized to establish for the City of Kirkland a plumbing examining board which will examine or cause the examination of all applications for journeymen licenses as required by this Chapter. Its members when established shall be Ex officio the Director of Sanitation, the Chief Plumbing Inspector, and the Chief Examiner of the Civil Service Commission, who shall be the secretary of the Board, provided; however, that until such time as such examining board is established the City of Kirkland will recognize and honor the examinations and decisions of the King County Journeymen's Examination Board.

Section 5.01.390 (a) SCHEDULE, Annual renewal fees for licenses required by this Chapter are as follows:

Plumbing Contractors' License. \$ 50.00

Lawn Sprinkler Contractors' License. 40.00

Journeymen Plumbers License Reserved.

Journey men Lawn Sprinkler Mechanics License Reserved.

(B) Expiration. All licenses shall expire on the 31st of January of each year. When a license is issued for less than six months before the date of expiration of the license the fee shall be one half the annual fee.

(c) Transferral. A contractor's license may be transferred to a new location upon payment of 10% of the annual fee.

(D) Renewal. (reserved)

Section 5.01.410 titled "Existing Licenses". Is hereby repealed.

Section 5.12.040 Water Service Piping. All water services piping is required to be of a conductable material and extend 10 feet past the exterior of the foundation walls.

Section 2. Ordinance No. 1140 in all other respects is hereby ratified and confirmed.

Section 3. This ordinance shall take effect and be in force five (5) days from and after it's passage by the Council on publication as required by law.
