

ORDINANCE NO. 2047

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON PROVIDING FOR THE ISSUANCE OF BONDS OF LOCAL IMPROVEMENT DISTRICT NO. 101 IN THE PRINCIPAL SUM OF \$11,133.64.

WHEREAS, by Ordinance No. 1121 passed and approved December 18, 1967, as amended by Ordinance No. 2042 passed and approved April 7, 1969, Local Improvement District No. 101 of the city was duly created; and

WHEREAS, the improvements provided by said ordinance to be constructed in Local Improvement District No. 101 have been completed; and

WHEREAS, the total cost of said improvements is \$16,775.46, and the assessment roll in said district has been confirmed in said amount by Ordinance No. 2034 passed and approved February 3, 1969; and

WHEREAS, the sum of \$5,641.82 was paid on said assessments during the 30-day period permitted by law for the payment of assessments without penalty or interest; and

WHEREAS, it will be necessary for the city to now issue bonds of said local improvement district in the principal sum of \$11,133.64;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Kirkland, Washington, as follows:

Section 1. That in order to provide for the payment of the costs of the improvements constructed in Local Improvement District No. 101 the city shall now issue bonds of said local improvement district in the principal sum of \$11,133.64. Said bonds shall be dated May 1, 1969, shall be in denominations of \$500 each, except for Bond No. 1 which shall be in the denomination of \$633.64, shall be numbered from 1 to 22 inclusive, shall bear interest at the rate of 6 per cent per annum payable annually on May 1 of each year and shall mature May 1, 1981.

All of said bonds shall be payable in lawful money of the United States of America at the office of the City Treasurer of Kirkland, Washington. Said bonds shall be redeemable at par, in numerical order, on any interest payment date whenever there shall be sufficient money in the Local

Improvement District No. 101 Fund to pay the same and all unpaid bonds of this local improvement district which are prior in numerical order to the last bonds to be redeemed over and above an amount sufficient for the payment of the interest next accruing on all the unpaid bonds of this local improvement district.

Notice of such intended redemption shall be given by one publication thereof in the official city newspaper not more than twenty nor less than ten days prior to such redemption date.

Section 2. Said bonds shall be in substantially the following form:

The City of Kirkland, a municipal corporation of the State of Washington, hereby promises to pay to bearer the sum of

FIVE HUNDRED DOLLARS
(SIX HUNDRED THIRTY-THREE AND 64/100 DOLLARS)

in lawful money of the United States of America, with interest thereon from the date hereof until payment of the principal sum has been made of duly provided for at the rate of 6% per annum payable annually, upon presentation and surrender to the City Treasurer of this bond and the annexed interest coupons as they severally become due.

This bond, principal and interest, is payable only out of the Local Improvement District No. 101 Fund created by Ordinance No. 1121 of the city, and from the Local Improvement Guaranty Fund of the city. Neither the Holder nor the owner of this bond shall have any claim therefor against the City of Kirkland except for payment from the special assessments made for the improvement for which said bond was issued,

and except as against the local improvement guaranty fund of the city and the city shall not be liableth to any holder or owner of such bond for any loss to the guaranty fund occurring in the lawful operation thereof by the city. The remedy of the holder or owner of a bond in case of nonpayment, shall be confined to the enforcement of the assessment and to the guaranty fund.

This bond is one of an issue aggregating in all the principal sum of \$11,133.64 and is payable on or before May 1, 1981, and is subject to call by the Treasurer of the City of Kirkland on any annual interest payment date whenever there shall be sufficient money in said Local Improvement District No. 101 Fund to pay the same and all unpaid bonds of this local improvement district which are prior in numerical order to this bond, over and above an amount sufficient for the payment of the interest next accruing on the unpaid bonds of this local improvement district.

In case this bond is called for payment before its final maturity, each and every interest coupon not accrued at the time of such payment shall be void. Call for payment of this bond shall be made by the City Treasurer by one publication of such call in the official city newspaper not more than twenty nor less than ten days prior to said call date, and when such call is made this bond shall be paid on the day the next interest coupon thereon shall become due after such call.

IN WHITNESS WHEREOF, the City of Kirkland, Washington, has caused this bond to be signed by its Mayor and attested by its Clerk under the corporate seal of the city and has caused the interest coupons hereto attached to be executed with the facsimile signatures of said officials this 1st day of May, 1969.

This coupon is subject to all the terms and conditions contained in the bond to which it is attached.

The Appropriate city officials are hereby authorized to do everything necessary for the prompt printing, issuance and delivery of said bonds and the proper application of the proceeds thereof.
