

ORDINANCE NO. 2083

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, FINDING THERE EXISTS AN EMERGENCY OF THE NATURE DEFINED IN RCW 35.33.080 AND RCW 35.33.090 RELATING TO THE REMODELING OF SPACE IN CERTAIN CIVIC BUILDINGS REQUIRED TO PROVIDE ADEQUATE MUNICIPAL SERVICES FOR THE CONSOLIDATED CITY OF KIRKLAND, AUTHORIZING THE EXPENDITURE OF AN ADDITIONAL \$24,000 FOR PAYMENT OF SUCH REMODELING AND AUTHORIZING A LOAN OF \$24,000 FROM THE CEMETERY IMPROVEMENT FUND TO THE CURRENT EXPENSE FUND AND ESTABLISHING THE TERMS FOR REPAYMENT OF SAID LOAN.

BE IT ORDAINED BY THE CITY COUNCIL of the City of Kirkland as follows:

Section 1. In order to provide adequate municipal services, facilities and administration for the consolidated City of Kirkland, the Kirkland City Council heretofore found (but following the adoption of the 1969 Budget) the necessity for and ordered the remodeling of certain Civic buildings, including portions of the Kirkland City Hall and new Council/Courtroom, located in a building adjacent to said City Hall. The increased scope of such remodeling required because of consolidation and general growth in the area and resultant demand for increased municipal and other local governmental services, together with the increasing costs thereof resulting from the inflationary condition of the general economy, the Council now finds to have created an emergency in the nature defined in RCW 35.33.080 and 35.33.090.

Section 2. There is hereby authorized and appropriated within the civic buildings capital outlay items of the 1969 budget for the City of Kirkland the expenditure of Twenty-Four Thousand Dollars (\$24,000) to be paid out of the current expense fund.

Section 3. A loan from the Cemetery Improvement Fund to the Current Expense Fund is hereby authorized in the amount of Twenty-Four Thousand Dollars (\$24,000) upon the following terms and conditions:

A. The transfer of funds from the Cemetery Improvement Fund to the Current Expense Fund shall be as of December 31, 1969.

B. Said loan shall carry an annual interest rate of five percent with interest to accrue from the date of transfer.


C. Said loan shall be fully repaid on or before December 31, 1974.

D. Annual interest payments shall be made on or before December 31st in each year during the life of said loan, together with such amount of principal payment, if any, as may be determined by the Director of Administration and Finance, provided that no payment on principal need be made until the due date of said loan to-wit: December 31, 1974.

Introduced at special meeting of the Kirkland City Council duly called for said purpose on December 8, 1969.

PASSED by the affirmative vote of not less than five members of the Kirkland City Council in regular meeting on the 15th day of December, 1969.
