

ORDINANCE NO. 2093

AN ORDINANCE OF THE CONSOLIDATED CITY OF KIRKLAND RELATING TO COMPREHENSIVE PLANNING, ADOPTING AN ARTERIAL CIRCULATION PLAN FOR THE ENTIRE CONSOLIDATED CITY, DECLARING SAID PLAN TO BE THE FIRST ELEMENT OF THE COMPREHENSIVE PLAN REQUIRED TO BE ADOPTED FOR SAID CITY PURSUANT TO RCW 35A.63.016, AMENDING AND SUPPLEMENTING THE KIRKLAND COMPREHENSIVE PLAN (ORDINANCE NO. 930) AND THE HOUGHTON COMPREHENSIVE PLAN (ORDINANCE NO. 132 H) AND FURTHER SUPPLEMENTING ORDINANCE NO. 2008 RELATING TO THE ADOPTION OF SIX YEAR ARTERIAL STREET IMPROVEMENT AND SIX YEAR URBAN ARTERIAL IMPROVEMENT PROGRAM FOR THE CONSOLIDATED CITY OF KIRKLAND.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

WHEREAS, RCW 35A.63.061 requires a code city to adopt a comprehensive plan containing at least a land use element and a traffic circulation element, and

WHEREAS, the Kirkland Planning Department, Planning Commission and Houghton Community Council have recommended and are presently conducting studies for preparation of a single comprehensive plan for the entire consolidated city of Kirkland, and

WHEREAS, said studies in relation to the arterial circulation element have been completed and, following public hearings thereon before the Planning Commission, recommended to the City Council, and

WHEREAS, said recommendation included the immediate effective adoption of said arterial circulation element by way of supplementation to the Kirkland and Houghton comprehensive plans and to the six year arterial street improvement plan and the six year urban arterial improvement plan (as heretofore adopted for the consolidated city in Ordinance No. 2008), and

WHEREAS, the recommended plan has been presented in public hearings as required by law,

NOW, THEREFORE:

Section 1. The arterial circulation plan for the city of Kirkland as prepared by Stevens, Thompson & Runyan, Inc., in conjunction with the Kirkland Planning Department is hereby adopted as the arterial circulation plan for the entire city of Kirkland, and is declared to be the circulation element required by RCW 35A.63.061(2).

Said plan, including maps, have been endorsed with the title and number of this ordinance, dated and signed by the Mayor and Director of Administration and Finance (ex officio City Clerk), and are incorporated herein as a part of this ordinance.

A copy of said plan shall be recorded in the office of the Director of Administration and Finance as a part of this ordinance, and copies shall be filed with the Planning Department for use of the general public and the affected departments of the city. A copy shall further be filed with the office of the Director of Public Services.


Section 2. The plan herein adopted provides a time table for future construction and improvement through 1990. Therefore, the six year arterial street improvement program and the six year urban arterial street improvement program as adopted for the consolidated city of Kirkland in Ordinance No. 2008 shall, as from time to time when required by state law, each be reviewed and updated in conformance with the plan adopted by this ordinance. To the extent that said plan as now adopted modifies said six year arterial street improvement program and said six year urban arterial street program as adopted in Ordinance No. 2008, each of said programs is hereby declared to be updated, modified and supplemented.

Section 3. To the extent that the plan herein adopted is subject to the jurisdiction of the Houghton Community Council as created by Ordinance No. 2001, said plan shall become effective either upon approval of the Houghton Community Council, or upon failure of said Community Council to disapprove within 60 days of the date of passage of this ordinance.

Section 4. Except as provided in Section 3, this ordinance shall be in full force and effect 5 days from and after its passage by the Council and publication as required by law.


