

ORDINANCE NO. 2141

AN ORDINANCE OF THE CONSOLIDATED CITY OF KIRKLAND RELATING TO COMPREHENSIVE PLANNING, ADOPTING A FIRE STATION LOCATION PLAN FOR THE ENTIRE CONSOLIDATED CITY, DECLARING SAID PLAN TO BE AN ELEMENT OF THE COMPREHENSIVE PLAN REQUIRED TO BE ADOPTED FOR SAID CITY PURSUANT TO RCW 35A.63.016, AMENDING AND SUPPLEMENTING THE KIRKLAND COMPREHENSIVE PLAN (ORDINANCE NO. 930) AND THE HOUGHTON COMPREHENSIVE PLAN (ORDINANCE NO. 126-H).

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

WHEREAS, RCW 35A.63.061 requires a code city to adopt a comprehensive plan containing at least a land use element and a traffic circulation element, and RCW 35A.63.062 provides for the inclusion of other elements, and

WHEREAS, the Kirkland Planning Department, Planning Commission and the Houghton Community Council have recommended and are presently conducting studies for preparation of a single comprehensive plan for the entire consolidated city of Kirkland, and

WHEREAS, such studies in relation to the location, construction, improvement, retention and disposition of fire station within the consolidated city of Kirkland have been conducted and completed by the Department of Fire Services for the City of Kirkland, and following presentation in public meeting thereon before the Kirkland Planning Commission and the Houghton Community Council, the fire station location plan has been recommended to the City Council, and

WHEREAS, the recommended plan has been presented in public hearings as required by law,

NOW, THEREFORE,

Section 1. The fire station location plan as prepared by the Greater Kirkland Department of Fire Services, in conjunction with Stevens, Thompson and Runyan, Inc., Consulting Engineers, King County Fire Protection District No. 41, and the Planning Department of the City of Kirkland, is hereby adopted as the fire station location plan for the entire City of Kirkland, and said plan, including, specifically, Alternate No. 1 of the plan implementation (being Alternate No. 1 of Chapter 4 thereof), is hereby declared to be the fire station location plan element of the Comprehensive Plan for the City of Kirkland as required by RCW 35A.63.

Said plan, including maps, have been endorsed with the title and number of this ordinance, dated and signed by the Mayor and Director of Administration and Finance (ex officio City Clerk), and are incorporated herein as a part of this ordinance.


A copy of said plan shall be recorded in the office of the Director of Administration and Finance as a part of this ordinance, and copies shall be filed with the Planning Department for use of the general public and the affected departments of the city. Copies shall be further filed with the office of the Director of Public Services, the Director of Fire Services for greater Kirkland, and the administrative office for King County Fire Protection District No. 41.

Section 2. To the extent that the plan herein adopted is subject to the jurisdiction of the Houghton Community Council as created by Ordinance No. 2001, said plan shall become effective either on approval of the Houghton Community Council, or upon failure of said community council to disapprove within 60 days of the date of passage of this ordinance.


Section 3. Except as provided in Section 2, this ordinance shall be in full force and effect five days from and after its passage by the council and publication as required by law.
