

ORDINANCE O-4661

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO DOMESTIC WATER SYSTEM CUSTOMER RATES FOR 2019 AND 2020 AND AMENDING SECTION 15.24.020 OF THE KIRKLAND MUNICIPAL CODE.

1 The City Council of the City of Kirkland do ordain as follows:

3 Section 1. Table 15.24.020 of Section 15.24.020 of the Kirkland
4 Municipal Code, as last amended by Ordinance 4534, which establishes the
5 monthly water charge required to be paid to the City by customers of the
6 Kirkland Water System, is further amended to read as follows:

7 Section 2. Effective date for new rates: For 2019, the monthly service
8 and consumption rates for water customers established in this ordinance shall
9 go into effect and become the rates to be charged as of December 1, 2018;
10 provided, however, that the monthly rates for water customers billed on the
11 City of Kirkland billing cycles number 2, number 4, and number 5 shall go into
12 effect January 1, 2019. For 2020, the monthly service and consumption rates
13 for water customers established in this ordinance shall go into effect and
14 become the rates to be charged as of December 1, 2019; provided, however,
15 that the monthly rates for water customers billed on the City of Kirkland billing
16 cycles number 2, number 4, and number 5 shall go into effect January 1,
17 2020.

19 Section 3. The water rates set forth in KMC 15.24.020, which is
20 amended by this ordinance, shall remain in force and effect until the rates set
21 forth in this ordinance go into effect.

23 Section 4. If any provision of this ordinance or its application to any
24 person or circumstance is held invalid, the remainder of the ordinance, or the
25 application of the provision to other persons or circumstances is not affected.

27 Section 5. This ordinance shall be in force and effect five days from
28 and after its passage by the Kirkland City Council and publication pursuant to
29 Section 1.08.017, Kirkland Municipal Code in the summary form attached to
30 the original of this ordinance and by this reference approved by the City
31 Council.

PUBLICATION SUMMARY
OF ORDINANCE NO. O-4661

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO DOMESTIC WATER SYSTEM CUSTOMER RATES FOR 2019 AND 2020 AND AMENDING SECTION 15.24.020 OF THE KIRKLAND MUNICIPAL CODE.

SECTION 1. Amends Section 15.24.020 of the Kirkland Municipal Code related to monthly water charges.

SECTIONS 2 - 3. Provides an effective date for the rates.

SECTION 4. Provides a severability clause for the ordinance.

SECTION 5. Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.

The full text of this Ordinance will be mailed without charge to any person upon request made to the City Clerk for the City of Kirkland. The Ordinance was passed by the Kirkland City Council at its meeting on the 2nd day of October, 2018.
